Recovery Residence Residential Rights Protection Act

- 3 FOR the purpose of requiring, beginning on a certain date, a behavioral health program or certain health professional, when referring an individual to receive services at a 4 5 recovery residence, to provide the individual with a certain list and provide certain 6 information to certain individuals; requiring certain recovery residence certification 7 requirements to include a requirement that a recovery residence make arrangements 8 for the receipt of certain services for certain residents; requiring, on or before a 9 certain date, the Department of Health and Mental Hygiene to publish on its Web 10 site a certain list; requiring the list to provide certain information; defining certain 11 terms; and generally relating to referrals to and the certification of recovery 12 residences.
