22 (a) In this subtitle the following words have the meanings indicated.



- 1 (B) (1) "ELECTRONIC CIGARETTE DEVICE" MEANS AN ELECTRONIC
- 2 DEVICE THAT CAN BE USED TO DELIVER NICOTINE OR ANY OTHER SUBSTANCE
- 3 INTENDED FOR HUMAN CONSUMPTION TO AN INDIVIDUAL TO SIMULATE SMOKING

- It is the intent of the General Assembly that the State protect the public and
- 3 employees from involuntary exposure to environmental tobacco smoke AND VAPOR in

- The purpose of this subtitle is to preserve and improve the health, comfort, and
- 8 environment of the people of the State by limiting exposure to environmental tobacco smoke

- Except as provided in § 24–505 of this subtitle, beginning on February 1, 2008, a

Nothing in this subtitle shall be construed to preempt a county or municipal government from enacting and enforcing more stringent measures to reduce involuntary exposure to environmental tobacco smoke AND VAPOR.

SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect 5 October 1, 2017.
