15 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,

19 (a) There is a Commission on the Commemoration of the 100th Anniversary of 20 the Passage of the 19th Amendment to the United States Constitution.

26	(c)	The Governor shall designate the chair of the Commission.
27	(d)	The Maryland State Archives shall provide staff for the Commission.
28	(e)	A member of the Commission:

(1) may not receive compensation as a member of the Commission; but

2 (2) is entitled to reimbursement for expenses under the Standard State 3 Travel Regulations, as provided in the State budget.

4 (f) The Commission shall:

5 (1) assemble an inventory of sites in Maryland that are significant to the 6 women's suffrage movement and the ratification of the 19th Amendment to the United 7 States Constitution;

8 (2) develop a plan for commemorating the events that occurred in 9 Maryland connected to the women's suffrage movement and the ratification of the 19th 10 Amendment to the United States Constitution;

(3) develop a strategy to encourage tourism related to the commemoration;

12 (4) make recommendations concerning facility development and repair 13 related to the commemoration;

14 (5) coordinate with the federal government, local governments in the State, 15 and neighboring jurisdictions regarding the development of plans commemorating the 16 women's suffrage movement and the ratification of the 19th Amendment to the United 17 States Constitution; and

18 (6) if appropriate, receive testimony from and consult with individuals who 19 are knowledgeable regarding the issues of interest to the Commission.

(g) On or before December 31, 2014, and annually thereafter for the following 5
years, the Commission shall report its activities, findings, and recommendations to the
Governor and, in accordance with § 2–1246 of the State Government Article, the General
Assembly.
