CHAPTER _____

1 AN ACT concerning

2 **Education – Grounds for Discipline**

3 FOR the purpose of altering certain procedures for suspending or dismissing certain public
4 school personnel; authorizing certain public school personnel to request arbitration
5 under certain circumstances; specifying the procedures for arbitration; assigning
6 responsibility for certain costs; providing that an arbitrator's award is final and
7 binding on the parties, subject to review by a circuit court; and generally relating to
8 procedures for suspending or dismissing certain public school personnel.

14 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
15 That the Laws of Maryland read as follows:

16 **Article – Education**

17 6–202.

1 (a) (1) On the recommendation of the county superintendent, a county board
2 may suspend or dismiss a teacher, principal, supervisor, assistant superintendent, or other
3 professional assistant for:

4 (i) Immorality;

5 (ii) Misconduct in office, including knowingly failing to report
6 suspected child abuse in violation of § 5–704 of the Family Law Article;

7 (iii) Insubordination;

8 (iv) Incompetency; or

9 (v) Willful neglect of duty.

10 (2) **(I)** Before removing an individual, the county board shall send the
11 individual a copy of the charges against [him] **THE INDIVIDUAL** and give [him] **THE**
12 **INDIVIDUAL** an opportunity within 10 days to request [a]:

13 1. **A hearing BEFORE THE COUNTY BOARD; OR**

14 2. **A HEARING BEFORE AN ARBITRATOR IN ACCORDANCE**
15 **WITH PARAGRAPH (5) OF THIS SUBSECTION.**

16 **(II) IF AN INDIVIDUAL’S REQUEST DOES NOT SPECIFY THAT THE**
17 **HEARING BE BEFORE AN ARBITRATOR, THE REQUEST SHALL BE CONSIDERED A**
18 **REQUEST FOR A HEARING BEFORE THE COUNTY BOARD.**

19 (3) If the individual requests a hearing **BEFORE THE COUNTY BOARD**
20 within the 10–day period:

21 (i) The county board promptly shall hold a hearing, but a hearing
22 may not be set within 10 days after the county board sends the individual a notice of the
23 hearing; and

24 (ii) The individual shall have an opportunity to be heard before the
25 county board, in person or by counsel, and to bring witnesses to the hearing.

26 (4) The individual may appeal from the decision of the county board to the
27 State Board.

28 (5) **(I) IF THE INDIVIDUAL OR THE INDIVIDUAL’S**
29 **REPRESENTATIVE REQUESTS A HEARING BEFORE AN ARBITRATOR WITHIN THE**
30 **10–DAY PERIOD, THE HEARING SHALL BE CONDUCTED IN ACCORDANCE WITH THIS**
31 **PARAGRAPH.**

1 (II) 1. AN ARBITRATOR SHALL BE SELECTED AS PROVIDED
2 IN THIS SUBPARAGRAPH.

3 2. IF THE SUPERINTENDENT AND THE INDIVIDUAL OR
4 THE INDIVIDUAL'S REPRESENTATIVE AGREE ON AN ARBITRATOR, THE ARBITRATOR
5 SHALL BE CHOSEN BY MUTUAL AGREEMENT OF THE PARTIES.

6 3. IF THE SUPERINTENDENT AND THE INDIVIDUAL OR
7 THE INDIVIDUAL'S REPRESENTATIVE CANNOT AGREE ON AN ARBITRATOR:

8 A. THE COUNTY BOARD SHALL REQUEST FROM THE
9 AMERICAN ARBITRATION ASSOCIATION A LIST OF THE ARBITRATORS THAT ARE
10 AVAILABLE TO HEAR THIS TYPE OF DISPUTE AND MAKE A DECISION IN A TIMELY
11 MANNER; AND

12 B. THE PARTIES SHALL ALTERNATELY STRIKE
13 ARBITRATORS FROM THE LIST.

14 (III) THE RULES OF LABOR ARBITRATION SHALL APPLY.

15 (IV) A STENOGRAPHIC RECORD SHALL BE MADE OF THE
16 PROCEEDINGS BEFORE THE ARBITRATOR.

17 (V) 1. THE ARBITRATOR SHALL DETERMINE WHETHER THE
18 COUNTY BOARD HAS SUFFICIENT CAUSE FOR SUSPENSION OR DISMISSAL OF THE
19 INDIVIDUAL.

20 2. A LESSER PENALTY THAN DISMISSAL MAY BE
21 IMPOSED BY THE ARBITRATOR ONLY TO THE EXTENT THAT EITHER PARTY
22 PROPOSES THE LESSER PENALTY IN THE PROCEEDING.

23 (VI) IN RENDERING A DECISION, THE ARBITRATION
24 PROCEEDING IS GOVERNED BY THIS SUBTITLE AND BY THE COLLECTIVE
25 BARGAINING AGREEMENT APPLICABLE TO THE INDIVIDUAL.

26 (VII) EXCEPT AS PROVIDED IN SUBPARAGRAPH (VIII) OF THIS
27 PARAGRAPH, ~~THE COUNTY BOARD SHALL PAY THE FULL~~ INDIVIDUAL SHALL PAY 25%
28 OF THE COST AND EXPENSES OF THE ARBITRATION AND THE COUNTY BOARD SHALL
29 PAY 75% OF THE COST AND EXPENSES OF THE ARBITRATION, INCLUDING:

30 1. THE AMERICAN ARBITRATION ASSOCIATION'S
31 ADMINISTRATIVE FEES;

1 **2. THE FULL COST OF THE STENOGRAPHY AND**
2 **TRANSCRIPTION SERVICES;**

3 **3. REASONABLE EXPENSES FOR REQUIRED TRAVEL;**

4 **4. REASONABLE FEES AND EXPENSES INCURRED OR**
5 **CHARGED BY THE ARBITRATOR; AND**

6 **5. REASONABLE EXPENSES ASSOCIATED WITH ANY**
7 **WITNESS OR EVIDENCE PRODUCED AT THE REQUEST OF THE ARBITRATOR.**

8 **(VIII) THE SUPERINTENDENT AND THE INDIVIDUAL SHALL PAY**
9 **THEIR OWN RESPECTIVE COSTS AND EXPENSES ASSOCIATED WITH ANY WITNESS OR**
10 **EVIDENCE PRODUCED BY THEM.**

11 **(IX) 1. THE AWARD BY THE ARBITRATOR IS FINAL AND**
12 **BINDING ON THE PARTIES.**

13 **2. AN INDIVIDUAL MAY REQUEST JUDICIAL REVIEW BY A**
14 **CIRCUIT COURT, WHICH SHALL BE GOVERNED BY THE MARYLAND UNIFORM**
15 **ARBITRATION ACT.**

16 **(6)** Notwithstanding any provision of local law, in Baltimore City the
17 suspension and removal of assistant superintendents and higher levels shall be as provided
18 by the personnel system established by the Baltimore City Board of School Commissioners
19 under § 4-311 of this article.

20 (b) (1) Except as provided in paragraph (3) of this subsection, the probationary
21 period of employment of a certificated employee in a local school system shall cover a period
22 of 3 years from the date of employment and shall consist of a 1-year employment contract
23 that may be renewed by the county board.

24 (2) (i) A county board shall evaluate annually a nontenured certificated
25 employee based on established performance evaluation criteria.

26 (ii) Subject to subparagraph (iii) of this paragraph, if the nontenured
27 certificated employee is not on track to qualify for tenure at any formal evaluation point:

28 1. A mentor promptly shall be assigned to the employee to
29 provide the employee comprehensive guidance and instruction; and

30 2. Additional professional development shall be provided to
31 the employee, as appropriate.

1 (iii) Nothing in this paragraph shall be construed to prohibit a county
2 board from assigning a mentor at any time during a nontenured certificated employee's
3 employment.

4 (3) (i) Subject to subparagraph (ii) of this paragraph, if a certificated
5 employee has achieved tenure in a local school system in the State and moves to another
6 local school system in the State, that employee shall be tenured if the employee's contract
7 is renewed after 1 year of probationary employment in the local school system to which the
8 employee relocated if:

9 1. The employee's final evaluation in the local school system
10 from which the employee departed is satisfactory or better; and

11 2. There has been no break in the employee's service between
12 the two systems of longer than 1 year.

13 (ii) A local school system may extend the probationary period for a
14 certificated employee subject to subparagraph (i) of this paragraph for a second year from
15 the date of employment if:

16 1. The employee does not qualify for tenure at the end of the
17 first year based on established performance evaluation criteria; and

18 2. The employee demonstrates a strong potential for
19 improvement.

20 (4) (i) The State Board shall adopt regulations that implement the
21 provisions of paragraphs (1) and (2) of this subsection and define the scope of a mentoring
22 program and professional development that will be aligned with the 3-year probationary
23 period.

24 (ii) The State Board shall adopt regulations to establish standards
25 for effective mentoring, including provisions to ensure that mentors provide mentoring
26 that:

27 1. Is focused;

28 2. Is systematic;

29 3. Is ongoing;

30 4. Is of high quality;

31 5. Is geared to the needs of each employee being mentored;

32 6. Includes observations; and

1 shall take effect in the local jurisdiction 6 months following the final adoption of the
2 regulations.

3 (7) Any performance evaluation criteria developed under this subsection
4 may not require student growth data based on State assessments to be used to make
5 personnel decisions before the 2016–2017 school year.

6 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
7 October 1, 2017.
