1 AN ACT concerning

2 **State Board of Pharmacy – Registered Pharmacy Technicians – Exemption for**
3 **Pharmacy Students**

4 FOR the purpose of providing that a certain provision of law requiring an individual to be
5 registered and approved by the State Board of Pharmacy as a pharmacy technician
6 before performing delegated pharmacy acts does not apply to a certain pharmacy
7 student; repealing an obsolete provision of law; and generally relating to the State
8 Board of Pharmacy, registered pharmacy technicians, and pharmacy students.

19 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
20 That the Laws of Maryland read as follows:

21 **Article – Health Occupations**

2 (a) In this title the following words have the meanings indicated.

3 (f) (1) “Delegated pharmacy act” means an activity that constitutes the
4 practice of pharmacy delegated by a licensed pharmacist under this title and regulations
5 adopted by the Board.

6 (2) “Delegated pharmacy act” does not include:

7 (i) An act within the parameters of a therapy management contract
8 as provided under Subtitle 6A of this title;

9 (ii) The administration of an influenza vaccination in accordance
10 with § 12-508 of this title;

11 (iii) The delegation of a pharmacy act by a registered pharmacy
12 technician, pharmacy student, or pharmacy technician trainee;

13 (iv) A pharmacy activity performed by a pharmacy student in
14 accordance with § 12-301(b) of this title;

15 (v) A pharmacy activity performed by an applicant for a license to
16 practice pharmacy in accordance with regulations adopted by the Board; or

17 (vi) The performance of other functions prohibited in regulations
18 adopted by the Board.

19 (h) “Direct supervision” means that a licensed pharmacist is physically available,
20 notwithstanding appropriate breaks, on-site and in the prescription area or in an area
21 where pharmacy services are provided to supervise the practice of pharmacy and delegated
22 pharmacy acts.

23 (s) “Pharmacy student” means an individual who is enrolled as a student in a
24 school or college of pharmacy approved by the Board or accredited by the Accreditation
25 Council for Pharmacy Education.

26 (w) “Registered pharmacy technician” means an individual who is registered with
27 the Board to perform delegated pharmacy acts.

28 12-6B-01.

29 (a) Except as otherwise provided in this title, [on or after January 1, 2007,] an
30 individual shall be registered and approved by the Board as a pharmacy technician before
31 the individual may perform delegated pharmacy acts.

1 (b) This section does not apply to [a]:

2 (1) A pharmacy technician trainee under the direct supervision of a
3 licensed pharmacist provided that the individual does not perform delegated pharmacy acts
4 for more than 6 months; OR

5 (2) A PHARMACY STUDENT WHO:

6 ~~(1)~~ (I) IS CURRENTLY COMPLETING THE FIRST YEAR OF A
7 PROFESSIONAL PHARMACY EDUCATION PROGRAM; AND

8 ~~(2)~~ (II) UNDER THE DIRECT SUPERVISION OF A LICENSED
9 PHARMACIST, PERFORMS DELEGATED PHARMACY ACTS IN ACCORDANCE WITH
10 REGULATIONS ADOPTED BY THE BOARD.

11 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
12 October 1, 2017.
