## A BILL ENTITLED

## Maryland Occupational Safety and Health Act – Voluntary Protection Program

3 FOR the purpose of establishing a certain Voluntary Protection Program in the Division of 4 Labor and Industry; requiring the Commissioner of Labor and Industry to recognize 5 certain employers under the Program; specifying the purpose of the Program; 6 requiring an employer who wishes to participate in the Program to submit a certain 7 application; requiring the Commissioner to establish the contents of the application 8 form as well as certain other documentation; authorizing the Commissioner to 9 conduct certain evaluations for certain purposes; providing that an employer's continued participation in the Program is contingent on certain factors; exempting a 10 11 place of employment that participates in the Program from certain inspections 12 except under certain circumstances; requiring the Commissioner to adopt certain 13 regulations to implement the Program; authorizing a certain place of employment to continue participation in the Program under certain circumstances; defining a 14 certain term; and generally relating to a Voluntary Protection Program under the 15 16 Maryland Occupational Safety and Health Act.

23 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,

24 That the Laws of Maryland read as follows:

Article - Labor and Employment

SUBTITLE 10. VOLUNTARY PROTECTION PROGRAM.

- 5 (A) (1) THERE IS A VOLUNTARY PROTECTION PROGRAM IN THE
- 6 DIVISION OF LABOR AND INDUSTRY.
- 7 (2) UNDER THE PROGRAM, THE COMMISSIONER SHALL RECOGNIZE
- 8 EMPLOYERS WITH PLACES OF EMPLOYMENT IN WHICH AN EXEMPLARY,
- 9 VOLUNTARILY IMPLEMENTED WORKER SAFETY AND HEALTH MANAGEMENT SYSTEM
- 10 HAS BEEN IMPLEMENTED THAT EXCEEDS BASIC COMPLIANCE WITH OCCUPATIONAL

- 23 (B) AFTER THE APPROVAL OF AN EMPLOYER'S APPLICATION FOR
- 24 PARTICIPATION, THE EMPLOYER'S CONTINUED PARTICIPATION IN THE PROGRAM IS
- 25 CONTINGENT ON THE EMPLOYER'S COMPLIANCE WITH THE REGULATIONS ADOPTED
- 26 BY THE COMMISSIONER UNDER § 5–1004 OF THIS SUBTITLE, AS DETERMINED BY
- 27 PERIODIC ON-SITE EVALUATIONS BY THE COMMISSIONER.
- 28 (C) EXCEPT AS PROVIDED IN SUBSECTION (D) OF THIS SECTION, DURING
- 29 THE PERIOD IN WHICH THE EMPLOYER IS A PARTICIPANT IN THE PROGRAM, THE
- 30 EMPLOYER'S PLACE OF EMPLOYMENT IS EXEMPT FROM OCCUPATIONAL SAFETY AND

- 1 HEALTH INSPECTIONS CONDUCTED BY THE COMMISSIONER UNDER TITLE 5,
- 2 SUBTITLE 2 OF THE LABOR AND EMPLOYMENT ARTICLE.
- 3 (D) NOTWITHSTANDING AN EMPLOYER'S PARTICIPATION IN THE PROGRAM,
- 4 A PLACE OF EMPLOYMENT IS NOT EXEMPT FROM INSPECTIONS OR INVESTIGATIONS
- 5 THAT ARISE FROM COMPLAINTS, REFERRALS, CATASTROPHES, FATALITIES,
- 6 ACCIDENTS, OR SIGNIFICANT TOXIC CHEMICAL RELEASES.
- 7 **5–1004**.
- 8 (A) THE COMMISSIONER SHALL ADOPT REGULATIONS TO IMPLEMENT THE 9 PROGRAM.
- 10 (B) THE REGULATIONS ADOPTED IN ACCORDANCE WITH SUBSECTION (A) OF 11 THIS SECTION SHALL INCLUDE REQUIREMENTS FOR:
- 12 (1) EVIDENCE OF SENIOR MANAGEMENT LEADERSHIP IN THE AREA
- 13 OF OCCUPATIONAL SAFETY AND HEALTH, ALONG WITH ACTIVE AND MEANINGFUL
- 14 EMPLOYEE INVOLVEMENT;
- 15 (2) COMPREHENSIVE HAZARD PREVENTION, MITIGATION, AND 16 CONTROL PROGRAMS;
- 17 (3) SYSTEMATIC ASSESSMENT OF OCCUPATIONAL HAZARDS;
- 18 (4) EMPLOYEE SAFETY AND HEALTH TRAINING; AND
- 19 (5) SAFETY AND HEALTH PROGRAM EVALUATION.
- SECTION 2. AND BE IT FURTHER ENACTED, That a place of employment
- 21 participating in the Voluntary Protection Program within the Division of Labor and
- 22 Industry on September 30, 2017, may continue its participation in the Voluntary Protection
- 23 Program administered under this Act without having to submit an application as required
- 24 under § 5–1002(c) of the Labor and Employment Article, as enacted by Section 1 of this Act,
- 25 or undergoing an on-site evaluation as required under § 5-1003(a) of the Labor and
- 26 Employment Article, as enacted by Section 1 of this Act.
- SECTION 3. AND BE IT FURTHER ENACTED, That this Act shall take effect
- 28 October 1, 2017.
