# A BILL ENTITLED

# 1 AN ACT concerning

# 2 Employees' Pension System – Optional Membership – Concurrent Membership 3 Prohibition

4 FOR the purpose of providing that certain membership in the Employees' Pension System  $\mathbf{5}$ shall terminate for certain individuals as of a certain date; providing that certain 6 individuals may receive a return of employee contributions under certain 7 circumstances; clarifying that a certain individual shall remain a member of the 8 Employees' Pension System with respect to certain employment; clarifying that 9 certain individuals may retire from the Employees' Pension System from certain employment, if eligible; and generally relating to membership in the Employees' 10 11 Pension System.

- SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
   That the Laws of Maryland read as follows:

- 21 (a) (1) Membership in the Employees' Pension System is optional for an 22 individual who is:
- 23 (i) an official, elected or appointed for a fixed term;
- 24 (ii) an employee of the Governor's office;

1 (iii) an employee of the Senate or House of Delegates;  $\mathbf{2}$ (iv) a member of the Prince George's County Board of License 3 Commissioners: 4 (v) an employee of Dorchester County who is not a member of the county's general pension and retirement program; or  $\mathbf{5}$ 6 except as provided in subsection (g) of this section, an employee (vi) 7 of a participating governmental unit who is employed by the participating governmental unit before the effective date of participation and who remains an employee of the 8 9 participating governmental unit through the effective date of participation. 10 (2)An individual described under paragraph (1)(i) through (v) of this subsection who elects to join the Employees' Pension System shall make the election at 11 12commencement of employment by filing a written application with the Board of Trustees 13on a form that the Board of Trustees provides. 14(3)An individual described under paragraph (1)(vi) of this subsection who 15elects to join the Employees' Pension System shall make the election prior to the effective date of participation by filing a written application with the Board of Trustees on a form 16that the Board of Trustees provides. 1718 An election to join the Employees' Pension System under this (4)19 subsection is a one-time, irrevocable election. 20(5)If an election to join the Employees' Pension System is not received by 21the Board of Trustees within the period of time described in paragraph (2) or (3) of this 22subsection, the individual may not elect to join the Employees' Pension System while 23employed in that position. 24The Board of Trustees shall adopt regulations to implement this (6)subsection. 2526(b)(1)Membership in the Employees' Pension System is not optional for 27individuals who are: 28supportive service employees of the Board of Education of Kent (i) 29County; 30 employees of the Town of Oakland; (ii) 31(iii) employees of the City of Frostburg; employees of the Town of Sykesville; or 32(iv)

(v) employees of the Town of University Park.

2 (2) Membership in the Employees' Pension System is not optional for an 3 individual who was employed in a position on or before June 30, 2015, that required the 4 individual to be a member of the Employees' Pension System, while the individual remains 5 in that position.

6 (c) (1) Subject to paragraph (2) of this subsection, membership in the 7 Employees' Pension System is optional for an individual described in § 23–201(a)(2)(iv) of 8 this subtitle who is elected or appointed as the Baltimore City Sheriff.

9 (2) An individual who is elected or appointed as the Baltimore City Sheriff 10 and who does not elect to join the Employees' Pension System is a member of the Law 11 Enforcement Officers' Pension System under Title 26 of this article as a condition of 12 employment.

(3) To elect to be a member of the Employees' Pension System under this
subsection, an individual shall make the election at commencement of employment by filing
a written application with the Board of Trustees on a form that the Board of Trustees
provides.

17 (4) An individual who does not elect membership within 6 months of the 18 date the individual begins serving as the Baltimore City Sheriff shall become a member of 19 the Law Enforcement Officers' Pension System.

20 (d) (1) This subsection applies to an individual described in § 23–201(a)(2)(iv) 21 of this subtitle who elects membership in the Employees' Pension System under this 22 section.

(2) An individual described in paragraph (1) of this subsection may elect
membership in the Law Enforcement Officers' Pension System if the county employing the
individual elects to become an eligible governmental unit in the Law Enforcement Officers'
Pension System in accordance with §§ 31–2A–02 through 31–2A–05 of this article.

(3) If an individual transfers to the Law Enforcement Officers' Pension
System under this subsection, the eligible governmental unit is responsible for all employer
contributions required for the individual under § 21–306.1 of this article.

30 (e) (1) This subsection applies only to an individual who is an employee of the 31 Town of Berwyn Heights on June 30, 2008.

32 (2) Subject to paragraph (3) of this subsection, membership in the 33 Employees' Pension System is optional for an individual described in paragraph (1) of this 34 subsection who elects membership on July 1, 2008.

1 (3) To elect to be a member of the Employees' Pension System, an 2 individual shall file a written application with the Board of Trustees on a form that the 3 Board of Trustees provides.

4 (f) (1) This subsection applies only to an individual who is an employee of the 5 City of College Park on June 30, 2014.

6 (2) Subject to paragraph (3) of this subsection, membership in the 7 Employees' Pension System is optional for an individual described in paragraph (1) of this 8 subsection who elects membership on July 1, 2014.

9 (3) To elect to be a member of the Employees' Pension System, an 10 individual shall file a written application with the Board of Trustees on a form that the 11 Board of Trustees provides.

12 (g) (1) This subsection applies to an individual who is employed by Prince 13 George's County as:

- 14 (i) the Chief Administrative Officer;
- 15 (ii) a Deputy Chief Administrative Officer;
  - (iii) a director of a county office or department;
- 17 (iv) a County Council Administrator;
- 18 (v) a Deputy Director of a county office or department; or
- 19 (vi) an Executive Director.

20 (2) (i) Membership in the Employees' Pension System is optional for an 21 individual who begins serving in a position listed in paragraph (1) of this subsection on or 22 after July 1, 2014.

(ii) An individual described under subparagraph (i) of this
 paragraph who elects to join the Employees' Pension System shall make the election at
 commencement of employment by filing a written application with the Board of Trustees
 on a form that the Board of Trustees provides.

- (3) Membership in the Employees' Pension System is mandatory for:

(i) an individual who:

1. is employed in one of the positions listed under paragraph
(1) of this subsection on or before June 30, 2014; and

$27 \\ 28 \\ 29$	SECTION 2. AND BE IT FURTHER ENACTED, That, as of the effective date of this Act, an individual who has two active membership accounts in the Employees' Pension System:
30 31 32 33	(1) shall cease to be a member in the Employees' Pension System with respect to membership established in accordance with § 23–204 of the State Personnel and Pensions Article as an elected official, if the individual was serving in the elected position on June 30, 2015;
34	(2) shall be disenrolled from the Employees' Pension System with respect

34 (2) shall be disenrolled from the Employees' Pension System with respect 35 to membership established in accordance with § 23–204 of the State Personnel and

Pensions Article as an elected official, if the individual was serving in the elected position
 on June 30, 2015;

3 (3) may receive a return of employee contributions with respect to
4 membership established in accordance with § 23–204 of the State Personnel and Pensions
5 Article as an elected official, as provided under the State Personnel and Pensions Article;

6 (4) shall remain a member of the Employees' Pension System with respect 7 to employment that requires membership in the Employees' Pension System other than in 8 accordance with § 23–204 of the State Personnel and Pensions Article; and

9 (5) may retire from the Employees' Pension System from employment that 10 requires membership in the Employees' Pension System other than in accordance with § 11 23–204 of the State Personnel and Pensions Article, if the individual meets the eligibility 12 requirements for retirement under the State Personnel and Pensions Article.

13 SECTION 3. AND BE IT FURTHER ENACTED, That this Act shall take effect July14 1, 2017.
