- 1 (3) The sum of the amount of compensatory damages awarded to each complainant under this subsection for future pecuniary losses, emotional pain, suffering, inconvenience, mental anguish, loss of enjoyment of life, or nonpecuniary losses, may not exceed:
- 5 (i) \$50,000, if the respondent employs not fewer than 15 and not 6 more than 100 employees in each of 20 or more calendar weeks in the current or preceding 7 calendar year;
