2 **Public Safety – SWAT Teams – ~~Reporting and Limitations~~ Standards**

3 FOR the purpose of requiring the Maryland Police Training and Standards Commission to
4 adopt a certain set of standards for the training and deployment of SWAT teams *and*
5 *of law enforcement officers not on a SWAT team who conduct no-knock warrant*
6 *service* in the State; ~~requiring each law enforcement agency to follow a certain set of~~
7 ~~standards; requiring, at certain intervals, a law enforcement agency that maintains~~
8 ~~a SWAT team to report certain information to the Governor's Office of Crime Control~~
9 ~~and Prevention using a certain format; requiring the Commission, in consultation~~

(a) In this subtitle the following words have the meanings indicated.

(G) "SWAT TEAM" MEANS AN AGENCY-DESIGNATED UNIT OF LAW
20 ENFORCEMENT OFFICERS WHO ARE SELECTED, TRAINED, AND EQUIPPED TO WORK
21 AS A COORDINATED TEAM TO RESOLVE CRITICAL INCIDENTS THAT ARE SO
22 HAZARDOUS, COMPLEX, OR UNUSUAL THAT THEY MAY EXCEED THE CAPABILITIES
23 OF FIRST RESPONDERS OR INVESTIGATIVE UNITS.

(a) The Commission has the following powers and duties:

(1) to establish standards for the approval and continuation of approval of
26 schools that conduct police entrance-level and in-service training courses required by the
27 Commission, including State, regional, county, and municipal training schools;

(22) to require:

(i) a statement condemning motorcycle profiling to be included in
30 existing written policies regarding other profiling; and

(ii) for entrance-level police training and for in-service level
32 training conducted by the State and each county and municipal police training school, that

1 the curriculum and minimum courses of study include, consistent with established law
 2 enforcement standards and federal and State constitutional provisions, training related to
 3 motorcycle profiling in conjunction with existing training regarding other profiling; [and]

4 (23) to perform any other act, including adopting regulations, that is
 5 necessary or appropriate to carry out the powers and duties of the Commission under this
 6 subtitle; AND

7 (24) TO DEVELOP STANDARDS FOR THE TRAINING AND DEPLOYMENT
 8 OF SWAT TEAMS IN THE STATE BASED ON BEST PRACTICES IN THE STATE AND
 9 NATIONWIDE CONSULT AND COOPERATE WITH COMMANDERS OF SWAT TEAMS TO
 10 DEVELOP STANDARDS FOR TRAINING AND DEPLOYMENT OF SWAT TEAMS AND OF
 11 LAW ENFORCEMENT OFFICERS WHO ARE NOT MEMBERS OF A SWAT TEAM WHO

14 SECTION 2. AND BE IT FURTHER ENACTED, That the Maryland Police Training
 15 and Standards Commission, in consultation with commanders of SWAT teams, as defined
 16 in § 3-201(g) of the Public Safety Article, shall create standards for the recording of data
 17 on the deployment of SWAT teams, including:

18 (1) the annual number of SWAT team deployments by a law enforcement
 19 agency; and

20 (2) for each SWAT team deployment:

21 (i) the city, county, and zip code where the deployment occurred;

22 (ii) the legal authority for the deployment, including the type of any
 23 warrant issued;

24 (iii) the age, gender, and race of any individual detained at the
 25 deployment location;

26 (iv) the number of arrests made at the deployment location;

27 (v) any property seized from the deployment location;

28 (vi) whether forcible entry was made at the deployment location;

29 (vii) whether a weapon was discharged by a SWAT team member at
 30 the deployment location;

31 (viii) whether a weapon was used or discharged by a resident or
 32 occupant of the deployment location;

1 ~~(ix) whether a domestic animal was present at the deployment~~
2 ~~location;~~

3 ~~(x) whether a person or domestic animal was injured or killed by a~~
4 ~~SWAT team member during a deployment; and~~

5 ~~(xi) whether a law enforcement officer or police K-9 was targeted,~~
6 ~~assaulted, injured, or killed by a resident or occupant of the deployment location.~~
