- FOR the purpose of altering the definition of "hunt" as it applies to the laws governing hunting and wildlife in the State to include the act of chasing or in any manner pursuing fox, whether armed or unarmed; repealing a provision of law excluding the sport of fox chasing from the definition of "hunt"; repealing the exemption for an unarmed person participating in an organized fox hunt from the requirement under certain circumstances to obtain a hunting license; and generally relating to fox hunting and chasing.

- WHEREAS, Hunting in Maryland requires the purchase of an annual hunting license, with all proceeds from the sale of the licenses credited to the State Wildlife
- 23 Management and Protection Fund for the purpose of financing the scientific investigation,
- 24 protection, propagation, and management of Maryland wildlife; and
- WHEREAS, Wildlife management in Maryland is critically dependent on these special fund license revenues given the absence of comparable General Fund financial

support, which financing model is consistent with how most states finance wildlife management activities; and

WHEREAS, Maryland's hunting community has been the singular voice for securing additional money for the State Wildlife Management and Protection Fund to support State wildlife managers in their continuing effort to meet the public's high expectations and high standards of accountability for the management of Maryland's coveted yet finite wildlife resources; and

8 WHEREAS, All persons who hunt in Maryland share a moral obligation to pay their 9 fair share for the privilege, including persons who participate in fox hunts and unarmed 10 fox chasing; now, therefore,

SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND, 12 That the Laws of Maryland read as follows:

## Article - Natural Resources

- 14 10-101.
- 15 (k) [(1)] "Hunt" means to [pursue]:
- 16 **(1) PURSUE**, capture, catch, kill, gig, trap, shoot, or attempt to pursue, capture, catch, kill, gig, trap, or shoot, or in any manner reduce any bird or mammal to personal possession.
- 19 (2) "Hunt" excludes the sport of fox chasing]; OR
- 20 **(2)** CHASE OR PURSUE IN ANY MANNER FOX, WHETHER ARMED OR 21 UNARMED.

- (b) To provide a fund to pay the expense of protecting and managing wildlife, and preventing unauthorized persons from hunting them, a person may not hunt or attempt to hunt during open season and in any permitted manner any game birds and mammals in the State without first having procured either a resident or nonresident hunter's license. A person may not hunt or attempt to hunt nongame birds and mammals in Baltimore County or Frederick County without first obtaining a license. A permanent resident of a government reservation may obtain a resident hunter's license.
- 30 (c) (1) Except as provided in paragraph (2) of this subsection, the following 31 persons are not required to obtain a hunter's license, bow and arrow stamp, black powder 32 stamp, or bonus antlered deer stamp:
  - (i) With respect to hunting on farmland only:

3 4 5	2. A tenant and the tenant's spouse, child, and child's spouse A tenant is a person holding land under a lease, or a sharecropper who resides in a dwelling on the land, but a tenant does not include any employee of the owner or tenant; and
6 7	3. A nonresident owner of a parcel of farmland and the owner's spouse, child, and child's spouse if:
8 9	A. The parcel of farmland is located in Maryland and ar adjacent state;
10 11	B. The owner's primary residence is on the parcel of farmland; and
12 13	C. The adjacent state extends similar privileges to a resident of Maryland;
14 15 16	(ii) Any resident serving in the armed forces of the United States while on leave in the State, during the resident's leave period, if, while hunting, the resident possesses a copy of the resident's official leave order; AND
17 18 19	(iii) Any person serving in the armed forces of the United States who has a service—connected disability, if, while hunting, the person possesses valid military identification[; and
20	(iv) Any unarmed person participating in an organized foxhunt].
21 22	SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect June 1, 2017.
