# Procurement Preferences – Blind Industries and Services of Maryland – Janitorial Products

FOR the purpose of clarifying that the requirement that a State or State aided or controlled
entity include in certain maintenance contracts a requirement that a prime
contractor procure certain products from the Blind Industries and Services of
Maryland under certain circumstances applies to products made or manufactured by
the Blind Industries and Services of Maryland; providing for the application of a
certain provision of law; and generally relating to procurement preferences related
to the Blind Industries and Services of Maryland.
