## FISCAL AND POLICY NOTE First Reader

Senate Bill 28

(Chair, Education, Health, and Environmental Affairs Committee)(By Request - Departmental - Lottery and Gaming Control Agency)

Education, Health, and Environmental Affairs

### **State Lottery Tickets - Prohibited Acts - Delivery Service**

This departmental bill generally prohibits a person or governmental unit from selling or purchasing a State lottery ticket on behalf of an individual located within or outside the State and delivering or transmitting the ticket or an electronic image of the ticket to an individual as a for-profit business delivery service. A person who violates the provisions of the bill is guilty of a misdemeanor and, on conviction, is subject to a fine of up to \$2,500 and/or imprisonment for up to three years.

## **Fiscal Summary**

**State Effect:** The criminal penalty provisions of the bill do not have a material impact on State finances or operations.

**Local Effect:** The criminal penalty provisions of the bill do not have a material impact on local finances or operations.

**Small Business Effect:** The State Lottery and Gaming Control Agency (SLGCA) has determined that this bill has minimal or no impact on small business (attached). The Department of Legislative Services concurs with this assessment.

## **Analysis**

**Current Law:** A person or governmental unit generally may not:

- hold itself out to the public as a State lottery sales agent without being licensed by SLGCA to act as a licensed agent;
- sell a State lottery ticket or share unless the person is a licensed agent or employee of a licensed agent;
- sell, purchase, or share a State lottery ticket at any price other than the price set by
- sell or purchase the prize validated for payment by SLGCA;
- sell a State lottery ticket or share to a minor;
- knowingly present, or transfer to another person to present, a counterfeit or altered State lottery ticket or share for payment; or
- knowingly purchase a State lottery ticket or share from another person with the intent to avoid specified payments to the State.

A person who violates any of these provisions is guilty of a misdemeanor and, on conviction, is subject to a fine of up to \$2,500 and/or imprisonment for up to three years.

**Background:** Federal law prohibits a person from selling lottery tickets by mail or over the Internet across state lines.

Generally, a misdemeanor may be brought in either the District Court or a circuit court, at the discretion of the prosecutor, if the penalty is confinement for three years or more or a fine of \$2.500 or more.
