AMENDMENTS TO SENATE BILL 740  
(First Reading File Bill)

AMENDMENT NO. 1

On page 1, in line 6, after “for” insert “reimbursing a county board of education or a nonprofit nonpublic school for certain portions of”; in the same line, after “meals” insert “in certain fiscal years”; in line 7, after “education” insert “or nonprofit nonpublic school”; in line 8, strike “a meal” and substitute “certain meals beginning in certain fiscal years”; and in line 9, after “education” insert “and nonprofit nonpublic schools”.

AMENDMENT NO. 2

On page 2, in line 13, after “FOR” insert “REIMBURSING A COUNTY BOARD OR A NONPROFIT NONPUBLIC SCHOOL FOR”; in line 16, after “PROGRAM” insert “ACCORDING TO THE FOLLOWING SCHEDULE:”

**(I) FOR FISCAL YEAR 2020, 10 CENTS PER STUDENT;**

**(II) FOR FISCAL YEAR 2021, 20 CENTS PER STUDENT; AND**

**(III) FOR FISCAL YEAR 2022 AND EACH FISCAL YEAR THEREAFTER, THE GREATER OF 30 CENTS PER STUDENT OR THE REQUIRED FEDERAL PER MEAL CHARGE TO STUDENTS**”;

in line 19, after “PROGRAM” insert “ACCORDING TO THE FOLLOWING SCHEDULE:”

**(I) FOR FISCAL YEAR 2020, 10 CENTS PER STUDENT;**

**(II) FOR FISCAL YEAR 2021, 20 CENTS PER STUDENT;**

(Over)

**(III) FOR FISCAL YEAR 2022, 30 CENTS PER STUDENT; AND**

**(IV) FOR FISCAL YEAR 2023 AND EACH FISCAL YEAR THEREAFTER, THE GREATER OF 40 CENTS PER STUDENT OR THE REQUIRED FEDERAL PER MEAL CHARGE TO STUDENTS**”;

in line 20, strike “A” and substitute “**(1) BEGINNING IN FISCAL YEAR 2022, A**”; in the same line, after “BOARD” insert “**OR NONPROFIT NONPUBLIC SCHOOL**”; in line 21, strike “OR LUNCH”; and after line 22, insert:

**“(2) BEGINNING IN FISCAL YEAR 2023, A COUNTY BOARD OR NONPROFIT NONPUBLIC SCHOOL MAY NOT CHARGE A STUDENT WHO IS ELIGIBLE FOR A REDUCED PRICE LUNCH FOR ANY PORTION OF THE COST OF THE MEAL.”**.

On page 4, in line 19, after “EDUCATION” insert “**OR A NONPROFIT NONPUBLIC SCHOOL**”.
