AMENDMENTS TO SENATE BILL 1090, AS AMENDED
(Third Reading File Bill)

AMENDMENT NO. 1

On page 1 of the bill, strike beginning with “authorizing” in line 5 down through “manner,” in line 7.

AMENDMENT NO. 2

On pages 2 and 3 of the bill, strike in their entirety the lines beginning with line 27 on page 2 through line 6 on page 3.

On page 3 of the bill, in lines 7, 17, and 18, in each instance, strike the brackets; in lines 7 and 17, strike “**(B)**” and “**(C), (D), OR (E)**”, respectively; in line 18, strike “**(C)**”; and in the same line, strike “**OR (E)**”.

On page 4 of the bill, strike in their entirety lines 21 through 28, inclusive.

On page 6 of the bill, in lines 18 and 19, in each instance, strike the brackets; in line 18, strike “**(E)**”; and in line 19, strike “**AND (D)**”.

AMENDMENT NO. 3

On page 1 of the Committee on Ways and Means Amendments (SB1090/175661/1), in line 3 of Amendment No. 1, strike the first set of brackets; in the same line, strike “**(D)**”.

On page 3 of the Committee on Ways and Means Amendments (SB1090/175661/1), in lines 22 and 23 of Amendment No. 1, strike “**PARAGRAPHS (1) AND (3)**” and substitute “**PARAGRAPH (1)**”.

(Over)

On page 4 of the Committee on Ways and Means Amendments (SB1090/175661/1), in line 2 of Amendment No. 2, strike “**(3)**”.

On page 4 of the Committee on Ways and Means Amendments (SB1090/175661/1), in Amendment No. 3, strike beginning with “**1.**” in line 3 down through “**4.**” in line 5.

Strike in its entirety Amendment No. 5 of the Committee on Ways and Means Amendments (SB1090/175661/1).

On page 4 of the Committee on Ways and Means Amendments (SB1090/175661/1), in line 2 of Amendment No. 6, strike “**(2) AND (3)**” and substitute “**(2)**”.

AMENDMENT NO. 4

On page 1 of the Committee on Ways and Means Amendments (SB1090/795360/1), in line 2 of Amendment No. 2, strike “**(A) IN THIS SECTION,**”; in line 2, strike “**WORLDWIDE**”; in line 5, strike “**(1)**”; in the same line, strike “**(2)**”; in the same line, strike “**(3)**”; and strike beginning with “**EXCEPT**” in line 9 down through “**SUBSECTION**” in line 10 and substitute “**A TRADE OR BUSINESS THAT IS A UNITARY BUSINESS SHALL DETERMINE THE PART OF THE CORPORATION’S MARYLAND MODIFIED INCOME AS FOLLOWS**”.

On pages 3 and 4 of the Committee on Ways and Means Amendments (SB1090/795360/1), in Amendment No. 2, strike beginning with “**(2)**” in line 20 on page 3 down through “**FRACTION:**” in line 2 on page 4.

On page 4 of the Committee on Ways and Means Amendments (SB1090/795360/1), in line 3 of Amendment No. 2, strike the first “**(II)**”; in the same line, strike “**(I)**”; and in line 6, strike “**PARAGRAPHS**” and substitute “**PARAGRAPH**”.
