AMENDMENTS TO SENATE BILL 292  
(First Reading File Bill)

AMENDMENT NO. 1

On page 1, strike beginning with “prohibiting” in line 6 down through “time;” in line 8.

AMENDMENT NO. 2

On page 1, in line 21, strike “**(1)**”; in the same line, strike “**OF AN ESTATE**” and substitute “**OWNED BY A DECEDENT**”; in line 23, strike “**(I)**” and substitute “**(1)**”; and in the same line, strike the first “**THE**” and substitute “**AN**”.

On page 2, in line 1, strike “**(II)**” and substitute “**(2)**”; strike beginning with “**IN**” in line 2 down through “**THE**” in line 7 and substitute “**OWNED BY THE DECEDENT TO THE SURVIVING SPOUSE IF:**”

**(I) THE SURVIVING SPOUSE CERTIFIES TO THE**”;

in line 7, strike “**IS**”; in line 8, strike “**SATISFIED**”; in line 10, strike “**3.**” and substitute “**(II)**”; strike beginning with “**CERTIFICATE**” in line 11 down through “**JURISDICTION**” in line 12 and substitute “**COPY OF THE DECEDENT’S DEATH CERTIFICATE AND SUITABLE PROOF OF THE EXISTENCE OF THE MARRIAGE**”; strike in their entirety lines 13 through 20, inclusive; in line 21, strike “**OF AN ESTATE**” and substitute “**OWNED BY A DECEDENT**”; in line 23, strike “**THE**” and substitute “**AN**”; in the same line, strike “**A**” and substitute “**THE**”; in lines 26 and 27, strike “**PERSON ENTITLED TO THE BOAT OR VESSEL**” and substitute “**SURVIVING SPOUSE OF THE DECEDENT**”; in line 28, strike “**AGENCY IS SATISFIED**” and substitute “**SURVIVING SPOUSE CERTIFIES TO THE AGENCY**”; and in line 29, strike “**AND**”.

On page 3, in line 5, after “\$5,000” insert “;AND”

**(III) THE AGENCY RECEIVES A COPY OF THE DECEDENT’S  
DEATH CERTIFICATE AND SUITABLE PROOF OF THE EXISTENCE OF THE  
MARRIAGE**”.

**AMENDMENT NO. 3**

On page 2, strike beginning with “ON” in line 8 down through “VEHICLE” in line 9; and in line 29, strike “ON THE BOAT OR VESSEL”.
