# AMENDMENTS TO SENATE BILL 502 (Third Reading File Bill)

## AMENDMENT NO. 1

On page 1, in line 2, strike "Higher Education – "; in the same line, before "Quasi– Endowment" insert "<u>Board of Regents and</u>"; in line 3, after the first "of" insert "<u>providing</u> that the unexpired or partial term of a member of the Board of Regents of the University System of Maryland appointed to fill a vacancy does not qualify as a full term for the purposes of the prohibition against a member serving a certain number of consecutive <u>full terms</u>;"; in the same line, strike "of the University System of Maryland"; in line 7, after "transfer;" insert "<u>providing for the application of a certain provision of this Act</u>;"; in the same line, strike "quasi–endowment funds of"; after line 8, insert:

"BY repealing and reenacting, without amendments,

<u>Article - Education</u> <u>Section 12-102(a) and (b)</u> <u>Annotated Code of Maryland</u> (2018 Replacement Volume)";

and in line 11, after "Section" insert "<u>12-102(g) and</u>".

AMENDMENT NO. 2

On page 2, after line 15, insert:

#### "<u>12–102.</u>

(a) (1) There is a body corporate and politic known as the University System of Maryland.

(2) <u>The University is an instrumentality of the State and a public</u> <u>corporation.</u>

(3) The University is an independent unit of State government.

(4) The exercise by the University of the powers conferred by this subtitle is the performance of an essential public function.

(b) <u>The government of the University System of Maryland is vested in the</u> <u>Board of Regents of the University System of Maryland.</u>

(g) (1) Except for the Secretary of Agriculture AND SUBJECT TO PARAGRAPH (2) OF THIS SUBSECTION, a member may not serve more than 2 consecutive full terms.

# (2) <u>THE UNEXPIRED OR PARTIAL TERM OF A MEMBER APPOINTED</u> TO FILL A VACANCY OCCURRING DURING A 5-YEAR TERM DOES NOT QUALIFY AS A FULL TERM FOR THE NEWLY APPOINTED MEMBER.".

On page 3, after line 3, insert:

"SECTION 2. AND BE IT FURTHER ENACTED, That § 12–102(g) of the Education Article, as enacted by Section 1 of this Act, applies to a member of the Board of Regents of the University System of Maryland serving on or after July 1, 2018.";

and in lines 4 and 9, strike "2." and "3.", respectively, and substitute "<u>3.</u>" and "<u>4.</u>", respectively.
