On page 1, in the sponsor line, strike "Senator Robinson" and substitute "<u>Senators</u> <u>Robinson, Conway, Pinsky, Bates, Nathan–Pulliam, Salling, Simonaire, Waugh, and</u> <u>Young</u>"; in line 2, strike "Coppin State University and Morgan State University" and substitute "<u>Higher Education</u>"; strike beginning with "Coppin" in line 4 down through the second "University" in line 5 and substitute "<u>Baltimore City Community College,</u> <u>Bowie State University, Coppin State University, Morgan State University, and the</u> <u>University of Maryland Eastern Shore</u>"; strike beginning with "prohibiting" in line 8 down through the semicolon in line 11; in lines 21 and 22 and 23 and 24, in each instance, strike "Coppin State University and Morgan State University" and substitute "<u>certain institutions of higher education</u>"; in line 23, strike "university's" and substitute "<u>institution's</u>"; in line 24, after "to" insert "jointly"; in lines 24 and 25, strike "on their campuses"; and strike beginning with "at" in line 26 down through "University" in line 27.

## AMENDMENT NO. 2

On page 2, strike in their entirety lines 29 and 30 and substitute:

On page 4, in lines 13, 15, 23, and 25, in each instance, strike "COPPIN STATE UNIVERSITY AND MORGAN STATE UNIVERSITY" and substitute "<u>BALTIMORE CITY</u> <u>COMMUNITY</u> COLLEGE, BOWIE STATE UNIVERSITY, COPPIN STATE UNIVERSITY, MORGAN STATE UNIVERSITY, AND THE UNIVERSITY OF <u>MARYLAND EASTERN SHORE</u>"; and in line 27, strike "UNIVERSITY'S" and substitute "<u>INSTITUTION'S</u>".

On page 5, in line 1, strike "Coppin State University and Morgan State University" and substitute "<u>Baltimore City Community College, Bowie State</u> <u>University, Coppin State University, Morgan State University, and the University of</u>

<u>Maryland Eastern Shore</u>"; in the same line, strike "each" and substitute "jointly"; and in line 2, strike "on their campuses".
