AMENDMENTS TO SENATE BILL 739
(Third Reading File Bill)

AMENDMENT NO. 1

On page 1, in line 4, after “teachers” insert “with certain experience”; in line 6, after the semicolon insert “prohibiting the two teacher members from being employed by the same county board of education;”; in line 8, after “lists” insert “jointly”; in line 11, after the semicolon insert “authorizing certain teacher members to attend and participate in certain sessions of the State Board; prohibiting a teacher member from voting on certain matters;”; and in line 15, after the semicolon insert “authorizing a certain parent member to attend and participate in certain sessions of the State Board;”.

AMENDMENT NO. 2

On page 2, in line 19, after “(I)” insert “1.”; in line 20, strike the period and substitute “:”; after line 20, insert:

“A. ONE OF WHOM SHALL HAVE EXPERIENCE TEACHING STUDENTS IN AT LEAST ONE OF THE ELEMENTARY GRADES, KINDERGARTEN THROUGH SIXTH GRADE; AND

B. ONE OF WHOM SHALL HAVE EXPERIENCE TEACHING STUDENTS IN AT LEAST ONE OF THE SECONDARY GRADES, SEVENTH THROUGH TWELFTH GRADE.”;

in line 21, after “(II)” insert “1.”; in the same line, strike “THE” and substitute “SUBJECT TO SUBSUBPARAGRAPH 2 OF THIS SUBPARAGRAPH, THE”; in line 22, strike “QUALIFIED” and substitute “THREE QUALIFIED ELEMENTARY SCHOOL TEACHERS AND THREE QUALIFIED SECONDARY SCHOOL TEACHERS”; in line 23, strike “INDIVIDUALS” and substitute “JOINTLY”; in line 24, strike “AS FOLLOWS:” and

substitute “BY THE MARYLAND STATE EDUCATION ASSOCIATION AND BALTIMORE TEACHERS UNION.”; and strike in their entirety lines 25 through 28, inclusive, and substitute:

“2. THE TWO TEACHER MEMBERS MAY NOT BE EMPLOYED BY THE SAME COUNTY BOARD OF EDUCATION.”

On page 3, after line 6, insert:

“(IV) A TEACHER MEMBER MAY ATTEND AND PARTICIPATE IN AN EXECUTIVE SESSION OF THE STATE BOARD.

(V) A TEACHER MEMBER MAY NOT VOTE ON ANY MATTER THAT RELATES TO APPEALS TO THE STATE BOARD UNDER § 6-202 OF THIS ARTICLE.”;

and after line 16, insert:

“(IV) THE PARENT MEMBER MAY ATTEND AND PARTICIPATE IN AN EXECUTIVE SESSION OF THE STATE BOARD.”
