On page 1, in line 4, after "teachers" insert "<u>with certain experience</u>"; in line 6, after the semicolon insert "<u>prohibiting the two teacher members from being employed</u> <u>by the same county board of education</u>;"; in line 8, after "<u>lists</u>" insert "<u>jointly</u>"; in line 11, after the semicolon insert "<u>authorizing certain teacher members to attend and</u> <u>participate in certain sessions of the State Board</u>; prohibiting a teacher member from <u>voting on certain matters</u>;"; and in line 15, after the semicolon insert "<u>authorizing a certain sessions of the State Board</u>;".

AMENDMENT NO. 2

On page 2, in line 19, after "(I)" insert "<u>1.</u>"; in line 20, strike the period and substitute "<u>:</u>"; after line 20, insert:

"<u>A.</u> <u>One of whom shall have experience</u> <u>TEACHING STUDENTS IN AT LEAST ONE OF THE ELEMENTARY GRADES,</u> <u>KINDERGARTEN THROUGH SIXTH GRADE; AND</u>

B. ONE OF WHOM SHALL HAVE EXPERIENCE TEACHING STUDENTS IN AT LEAST ONE OF THE SECONDARY GRADES, SEVENTH THROUGH TWELFTH GRADE.";

in line 21, after "(II)" insert "<u>1.</u>"; in the same line, strike "THE" and substitute "<u>SUBJECT TO SUBSUBPARAGRAPH 2 OF THIS SUBPARAGRAPH, THE</u>"; in line 22, strike "QUALIFIED" and substitute "<u>THREE QUALIFIED ELEMENTARY SCHOOL</u> <u>TEACHERS AND THREE QUALIFIED SECONDARY SCHOOL TEACHERS</u>"; in line 23, strike "INDIVIDUALS" and substitute "JOINTLY"; in line 24, strike "AS FOLLOWS:" and

substitute "BY THE MARYLAND STATE EDUCATION ASSOCIATION AND BALTIMORE TEACHERS UNION."; and strike in their entirety lines 25 through 28, inclusive, and substitute:

"2. <u>The two teacher members may not be</u> <u>EMPLOYED BY THE SAME COUNTY BOARD OF EDUCATION.</u>".

On page 3, after line 6, insert:

"(IV) <u>A TEACHER MEMBER MAY ATTEND AND PARTICIPATE IN</u> <u>AN EXECUTIVE SESSION OF THE STATE BOARD.</u>

(V) <u>A TEACHER MEMBER MAY NOT VOTE ON ANY MATTER</u> THAT RELATES TO APPEALS TO THE STATE BOARD UNDER § 6–202 OF THIS <u>ARTICLE.</u>";

and after line 16, insert:

"(IV) <u>The parent member may attend and participate</u> <u>IN AN EXECUTIVE SESSION OF THE STATE BOARD.</u>".
