## Baltimore County Board of Education - Education Transparency Act

- 3 FOR the purpose of requiring actions of the Baltimore County Board of Education to be 4 taken at a public meeting, subject to a certain exception; requiring that a record of a 5 certain meeting and certain actions be made public; requiring any action of the 6 county board to be recorded by a verbal roll call vote of certain members of the county 7 board; requiring the county board to keep a formal record of certain public meetings; 8 requiring any action of the county board to be made publicly available on a certain website within a certain time; requiring certain actions on the county board's website 9 to include a certain description and a certain link to a video recording, under certain 10 11 circumstances; authorizing the county board to take certain actions in a closed 12 session in accordance with a certain provision of law; and generally relating to 13 meetings of the Baltimore County Board of Education.

- 19 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
- 20 That the Laws of Maryland read as follows:
- 21 Article Education
- 22 3–2B–09.
- 23 **(A)** At the first meeting of the county board in December of each year, the county board shall elect a chair and vice chair from among the members.



- 1 (B) (1) EXCEPT FOR THE ACTIONS AUTHORIZED BY SUBSECTION (C) OF
- 2 THIS SECTION, ALL ACTIONS OF THE COUNTY BOARD SHALL BE TAKEN AT A PUBLIC
- 3 MEETING AND A RECORD OF THE MEETING AND ALL ACTIONS SHALL BE MADE
- 4 PUBLIC.
- 5 (2) (I) ANY ACTION OF THE COUNTY BOARD SHALL BE RECORDED
- 6 BY A VERBAL ROLL CALL VOTE OF EACH INDIVIDUAL MEMBER OF THE COUNTY
- 7 BOARD WHO IS PRESENT AT THE PUBLIC MEETING.
- 8 (II) THE COUNTY BOARD SHALL KEEP A FORMAL RECORD OF
- 9 EACH PUBLIC MEETING.
- 10 (3) (I) ANY ACTION OF THE COUNTY BOARD SHALL BE MADE
- 11 PUBLICLY AVAILABLE ON THE COUNTY BOARD'S WEBSITE WITHIN 12 HOURS OF THE
- 12 TIME THE ACTION WAS TAKEN.
- 13 (II) ON THE COUNTY BOARD'S WEBSITE, EACH ACTION SHALL
- 14 **INCLUDE:**
- 15 A FULL AND ACCURATE DESCRIPTION OF THE ACTION
- 16 TO INFORM THE PUBLIC OF THE MOTION OR QUESTION; AND
- 2. A LINK OR REFERENCE TO THE RELATED VIDEO
- 18 RECORDING OF THE COUNTY BOARD MEETING, IF AVAILABLE.
- 19 (C) THE COUNTY BOARD MAY TAKE ACTIONS IN A CLOSED SESSION IN
- 20 ACCORDANCE WITH § 3–305 OF THE GENERAL PROVISIONS ARTICLE.
- 21 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July
- 22 1, 2018.
