A BILL ENTITLED

1 AN ACT concerning

2 **State Board of Law Examiners – Sunset Extension**

3 FOR the purpose of continuing the State Board of Law Examiners in accordance with the
4 provisions of the Maryland Program Evaluation Act (sunset law) by extending to a
5 certain date the termination provisions relating to the statutory and regulatory
6 authority of the Board; requiring that an evaluation of the Board and the statutes
7 and regulations that relate to the Board be performed on or before a certain date;
8 and generally relating to the State Board of Law Examiners.

24 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
25 That the Laws of Maryland read as follows:

2 Subject to the evaluation and reestablishment provisions of the Maryland Program
3 Evaluation Act, this subtitle shall terminate and be of no effect after July 1, **[2020] 2030**.

6 (a) On or before December 15 of the evaluation year specified, the Department
7 shall:

8 (1) conduct a preliminary evaluation of each governmental activity or unit
9 to be evaluated under this section; and

10 (2) prepare a report on each preliminary evaluation conducted.

11 (b) Each of the following governmental activities or units and the statutes and
12 regulations that relate to the governmental activities or units are subject to preliminary
13 evaluation in the evaluation year specified:

16 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
17 October 1, 2018.
