3 FOR the purpose of establishing the Community Development Program in the Department of Housing and Community Development; requiring the Department to perform 4 $\mathbf{5}$ certain duties; establishing the Community Development Board in the Department; 6 providing for the membership and chair of the Board; requiring the Board to perform 7 certain duties; establishing the Community Development Fund as a special, 8 nonlapsing fund; specifying the purpose of the Fund; requiring the Department to 9 administer the Fund with the assistance of the Board; requiring the State Treasurer 10 to hold the Fund and the Comptroller to account for the Fund; specifying the contents 11 of the Fund; specifying the purpose for which the Fund may be used; providing for 12 the investment of money in and expenditures from the Fund; defining certain terms; 13providing for the construction of this Act; and generally relating to the Community Development Program Act. 14
