A BILL ENTITLED

- 1 AN ACT concerning
- 2 Motor Vehicles Duplicate Driver's Licenses Victims of Robbery or Burglary
- 3 FOR the purpose of authorizing a victim of a robbery or burglary whose driver's license is 4 taken during the robbery or burglary to drive without a license for a certain period of time under certain circumstances; extending the period of time, under certain 5 6 circumstances, during which a victim of a robbery or burglary whose license is taken 7 during the robbery or burglary must apply for a duplicate license; requiring the 8 Motor Vehicle Administration, when processing an application for a duplicate license of a victim of a robbery or burglary whose license is taken during the robbery or 9 10 burglary, to issue the duplicate license free of charge; and generally relating to 11 duplicate driver's licenses and victims of robbery or burglary.

- 17 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
- 18 That the Laws of Maryland read as follows:
- 19 Article Transportation
- 20 16–112.
- 21 (a) In this section, "display" means the manual surrender of the licensee's license 22 into the hands of the demanding officer for inspection.
- 23 (b) [Each] EXCEPT AS PROVIDED IN SUBSECTION (F) OF THIS SECTION,

- EACH individual driving a motor vehicle on any highway in this State shall have his license with him.
- 3 (c) Each individual driving a motor vehicle on any highway in this State shall 4 display the license to any uniformed police officer who demands it.
- 5 (d) Each individual driving a motor vehicle on any highway in this State shall, if 6 requested by the officer, sign his usual signature in the presence of the officer so that the 7 officer may determine whether he is the licensee.
- 8 (e) A person may not give the name of another person or give a false or fictitious 9 name to any uniformed police officer who is attempting to determine the identity of a driver 10 of a motor vehicle.
- 11 (F) A VICTIM OF A ROBBERY OR BURGLARY WHOSE LICENSE IS TAKEN
 12 DURING THE ROBBERY OR BURGLARY AND WHO FILES A POLICE REPORT OF THE
 13 ROBBERY OR BURGLARY IN A TIMELY MANNER MAY DRIVE WITHOUT A LICENSE FOR
 14 NOT MORE THAN 2 WEEKS AFTER THE ROBBERY OR BURGLARY.

- 16 (a) In this section, "mutilated" includes any imperfection of or in a driver's license, 17 after its issuance, that renders it unsuitable for identification purposes or for verifying its 18 authenticity and validity.
- (b) [If] EXCEPT AS PROVIDED IN SUBSECTION (E) OF THIS SECTION, IF a driver's license is lost, stolen, mutilated, or destroyed, the licensee immediately shall apply for and, after furnishing information satisfactory to the Administration and payment of the required fee, is entitled to obtain a duplicate license. If the duplicate license being applied for is of a type requiring a photo and the licensee is temporarily absent from this State, the Administration may issue a regular license bearing the notation that it is valid without a photo until 15 days after the licensee first returns to this State.
- 26 (c) A licensee who is at least 21 years may apply for a duplicate license that 27 includes a frontal photograph of the licensee.
- 28 (d) If a person recovers an original license for which a duplicate has been issued, 29 the person promptly shall surrender the original license to the Administration.
- 30 **(E) (1)** A VICTIM OF A ROBBERY OR BURGLARY WHOSE LICENSE IS TAKEN 31 DURING THE ROBBERY OR BURGLARY AND WHO FILES A POLICE REPORT OF THE 32 ROBBERY OR BURGLARY IN A TIMELY MANNER SHALL APPLY FOR A DUPLICATE 33 LICENSE NOT MORE THAN 2 WEEKS AFTER THE ROBBERY OR BURGLARY.
- 34 (2) If A VICTIM OF A ROBBERY OR BURGLARY WHOSE LICENSE IS 35 TAKEN DURING THE ROBBERY OR BURGLARY PRESENTS A POLICE REPORT OF THE

- 1 ROBBERY OR BURGLARY WHEN APPLYING FOR A DUPLICATE LICENSE, THE
- 2 ADMINISTRATION SHALL ISSUE A DUPLICATE LICENSE FREE OF CHARGE.
- 3 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
- 4 October 1, 2018.
