- 23 (C) (1) THE COUNTY MAY IMPOSE, BY LAW, A FEE ON A STORE FOR THE
- 24 USE OF DISPOSABLE BAGS AS A PART OF A RETAIL SALE OF PRODUCTS.
- 25 (2) THE FEE IMPOSED UNDER PARAGRAPH (1) OF THIS SUBSECTION
- 26 MAY NOT EXCEED 5 CENTS FOR EACH DISPOSABLE BAG USED.
- SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
- 28 October 1, 2018.
