- 2 LEAST 4 SUCCESSIVE WEEKS; AND
- 3 (3) MAIL NOTICE OF THE HEARING DATE, TIME, AND LOCATION TO
- 4 THE PARENT OR GUARDIAN OF EACH CHILD THAT ATTENDS THE PUBLIC SCHOOL
- 5 LOCATED ON THE GROUNDS WHERE THE INSTALLATION IS PROPOSED.
- 6 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
- 7 October 1, 2018.
