1 AN ACT concerning

2 **Dorchester County – Alcoholic Beverages – Class C Per Diem Licenses –**
3 **Catering Club Events**

4 FOR the purpose of specifying that a holder of a Class C per diem beer license, a Class C
5 per diem beer and wine license, or a Class C per diem beer, wine, and liquor license
6 may cater an event conducted by a club at the place described in the license on
7 certain days; and generally relating to alcoholic beverages in Dorchester County.

18 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
19 That the Laws of Maryland read as follows:

20 **Article – Alcoholic Beverages**

4 (a) There is a Class C per diem beer and a Class C per diem beer and wine license.

5 (b) A holder of a Class C per diem beer license or a Class C per diem beer and
6 wine license:

7 (1) may cater an event **CONDUCTED BY A CLUB** at the place described in
8 the license on the effective days of the license;

9 (2) shall distribute at the event for which the license is issued a wristband
10 to each individual who is at least 21 years old; and

11 (3) may not serve an alcoholic beverage to any individual who does not
12 wear the wristband.

13 (c) The fee for a Class C per diem beer license or Class C per diem beer and wine
14 license is \$15 per day.

15 (d) A person who violates this section is subject to:

16 (1) for a first offense, a fine of \$50; and

17 (2) for a subsequent offense, a fine not exceeding \$500 and denial of
18 subsequent requests for a license for catering additional events.

20 (a) There is a Class C per diem beer, wine, and liquor license.

21 (b) A holder of a Class C per diem beer, wine, and liquor license:

22 (1) may cater an event **CONDUCTED BY A CLUB** at the place described in
23 the license on the effective days of the license;

24 (2) shall distribute at the event for which the license is issued a wristband
25 to each individual who is at least 21 years old; and

26 (3) may not serve an alcoholic beverage to any individual who does not
27 wear the wristband.

28 (c) The fee for the license is \$25 per day.

1 (d) A person who violates this section is subject to:

2 (1) for a first offense, a fine of \$50; and

3 (2) for a second offense, a fine not exceeding \$500 and denial of subsequent
4 requests for a license for catering additional events.

5 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July
6 1, 2018.
