A BILL ENTITLED

1 AN ACT concerning

2 **Maryland Estate Tax – Unified Credit**

3 FOR the purpose of altering a certain limit on the unified credit used for determining the
4 Maryland estate tax for decedents dying on or after a certain date; altering a certain
5 limitation on the amount of the Maryland estate tax for decedents dying on or after
6 a certain date; making a conforming change; and generally relating to the Maryland
7 estate tax.

1 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
2 That the Laws of Maryland read as follows:

3 **Article – Tax – General**

4 7–309.

5 (a) Notwithstanding an Act of Congress that repeals or reduces the federal credit
6 under § 2011 of the Internal Revenue Code, the provisions of this subtitle in effect before
7 the passage of the Act of Congress shall apply with respect to a decedent who dies after the
8 effective date of the Act of Congress so as to continue the Maryland estate tax in force
9 without reduction in the same manner as if the federal credit had not been repealed or
10 reduced.

11 (b) (1) Except as provided in paragraphs (2) through (8) of this subsection and
12 subsection (c) of this section, after the effective date of an Act of Congress described in
13 subsection (a) of this section, the Maryland estate tax shall be determined using:

14 (i) the federal credit allowable by § 2011 of the Internal Revenue
15 Code as in effect before the reduction or repeal of the federal credit pursuant to the Act of
16 Congress; and

17 (ii) other provisions of federal estate tax law[, including the
18 applicable unified credit allowed against the federal estate tax,] as in effect on the date of
19 the decedent's death.

20 (2) Except as provided in paragraphs (3) through (8) of this subsection and
21 subsection (c) of this section, if the federal estate tax is not in effect on the date of the
22 decedent's death, the Maryland estate tax shall be determined using:

23 (i) the federal credit allowable by § 2011 of the Internal Revenue
24 Code as in effect before the reduction or repeal of the federal credit pursuant to the Act of
25 Congress; and

26 (ii) other provisions of federal estate tax law[, including the
27 applicable unified credit allowed against the federal estate tax,] as in effect on the date
28 immediately preceding the effective date of the repeal of the federal estate tax.

29 (3) (i) Notwithstanding any increase in the unified credit allowed
30 against the federal estate tax for decedents dying after 2003, the unified credit used for
31 determining the Maryland estate tax for a decedent [dying before January 1, 2019,] may
32 not exceed the applicable credit amount corresponding to an applicable exclusion amount,
33 within the meaning of § 2010(c) of the Internal Revenue Code, of:

34 1. \$1,000,000 for a decedent dying before January 1, 2015;

35 2. \$1,500,000 for a decedent dying on or after January 1,

1 2015, but before January 1, 2016;

2 3. \$2,000,000 for a decedent dying on or after January 1,
3 2016, but before January 1, 2017;

4 4. \$3,000,000 for a decedent dying on or after January 1,
5 2017, but before January 1, 2018; [and]

6 5. \$4,000,000 for a decedent dying on or after January 1,
7 2018, but before January 1, 2019; AND

8 **6. \$5,000,000 FOR A DECEDENT DYING ON OR AFTER**
9 **JANUARY 1, 2019.**

10 (ii) The Maryland estate tax shall be determined without regard to
11 any deduction for State death taxes allowed under § 2058 of the Internal Revenue Code.

12 (iii) Unless the federal credit allowable by § 2011 of the Internal
13 Revenue Code is in effect on the date of the decedent's death, the federal credit used to
14 determine the Maryland estate tax may not exceed 16% of the amount by which the
15 decedent's taxable estate, as defined in § 2051 of the Internal Revenue Code, exceeds:

16 1. \$1,000,000 for a decedent dying before January 1, 2015;

17 2. \$1,500,000 for a decedent dying on or after January 1,
18 2015, but before January 1, 2016;

19 3. \$2,000,000 for a decedent dying on or after January 1,
20 2016, but before January 1, 2017;

21 4. \$3,000,000 for a decedent dying on or after January 1,
22 2017, but before January 1, 2018; AND

23 5. \$4,000,000 for a decedent dying on or after January 1,
24 2018, but before January 1, 2019; and

25 6. [the applicable exclusion amount corresponding to the
26 applicable unified credit under paragraph (1) or (2) of this subsection] **\$5,000,000** for a
27 decedent dying on or after January 1, 2019.

28 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July
29 1, 2018.
