A BILL ENTITLED

1 AN ACT concerning

2 **Income Tax – Personal Exemptions – Alteration**

3 FOR the purpose of altering the determination of the number of exemptions that an
4 individual may use to calculate a certain deduction under the Maryland income tax;
5 providing for the application of this Act; and generally relating to a deduction for
6 certain exemptions under the Maryland income tax.

12 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
13 That the Laws of Maryland read as follows:

14 **Article – Tax – General**

15 10–211.

1 (a) SUBJECT TO THE PROVISIONS OF THIS SECTION, AN INDIVIDUAL MAY
2 DEDUCT AN EXEMPTION FOR:

3 (1) THE TAXPAYER;

4 (2) THE SPOUSE OF THE TAXPAYER IF:

5 (I) A JOINT RETURN IS NOT MADE BY THE TAXPAYER AND THE
6 SPOUSE; AND

7 (II) THE SPOUSE, FOR THE CALENDAR YEAR IN WHICH THE
8 TAXABLE YEAR OF THE TAXPAYER BEGINS, HAS NO GROSS INCOME AND IS NOT A
9 DEPENDENT OF ANOTHER TAXPAYER; AND

10 (3) EACH INDIVIDUAL WHO IS A DEPENDENT, AS DEFINED IN § 152 OF
11 THE INTERNAL REVENUE CODE, OF THE TAXPAYER FOR THE TAXABLE YEAR.

12 (B) Except as provided in subsection [(b)] (C) of this section, whether or not a
13 federal return is filed, to determine Maryland taxable income, an individual other than a
14 fiduciary may deduct as an exemption:

15 (1) \$3,200 for each exemption that the individual may deduct [in the
16 taxable year to determine federal taxable income under § 151 of the Internal Revenue Code]
17 UNDER SUBSECTION (A) OF THIS SECTION;

18 (2) an additional \$3,200 for each dependent, as defined in § 152 of the
19 Internal Revenue Code, who is at least 65 years old on the last day of the taxable year;

20 (3) an additional \$1,000 if the individual, on the last day of the taxable
21 year, is at least 65 years old; and

22 (4) an additional \$1,000 if the individual, on the last day of the taxable
23 year, is a blind individual, as described in § 10-208(c) of this subtitle.

24 [(b)] (C) (1) If an individual other than one described in paragraph (2) of this
25 subsection has federal adjusted gross income for the taxable year greater than \$100,000,
26 the amount allowed for each exemption under subsection [(a)(1) or (2)] (B)(1) OR (2) of
27 this section is limited to:

28 (i) \$1,600 if federal adjusted gross income for the taxable year does
29 not exceed \$125,000;

30 (ii) \$800 if federal adjusted gross income for the taxable year is
31 greater than \$125,000 but not greater than \$150,000; and

1 (iii) \$0 if federal adjusted gross income for the taxable year is greater
2 than \$150,000.

3 (2) If a married couple filing a joint return or an individual described in §
4 2 of the Internal Revenue Code as a head of household or as a surviving spouse has federal
5 adjusted gross income for the taxable year greater than \$150,000, the amount allowed for
6 each exemption under subsection [(a)(1) or (2)] **(B)(1) OR (2)** of this section is limited to:

7 (i) \$1,600 if federal adjusted gross income for the taxable year does
8 not exceed \$175,000;

9 (ii) \$800 if federal adjusted gross income for the taxable year is
10 greater than \$175,000 but not greater than \$200,000; and

11 (iii) \$0 if federal adjusted gross income for the taxable year is greater
12 than \$200,000.

13 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July
14 1, 2018, and shall be applicable to all taxable years beginning after December 31, 2017.
