HOUSE BILL 376

1 One member of the Board of Regents shall be a student in good (c)(1) $\mathbf{2}$ academic standing at the University who: 3 (i) Is at least 18 years old; and 4 (ii) Has the qualifications required to be student body president. $\mathbf{5}$ The student member serves for a term of 1 year and until a successor is (2)6 appointed and qualifies. The student may be a resident of a state other than Maryland, but the 7 (3)8 residency status of the student may not be considered in determining the number of resident or nonresident regents as provided for in subsection (d)(2) of this section. 9 Except for the student member, each member serves for a term 10 (d)(1)(i) 11 of 5 years and until a successor is appointed and qualifies. The terms are staggered as 12required by the terms of the members serving on December 31, 2012. 13[A] EXCEPT AS PROVIDED IN SUBSUBPARAGRAPH 2 (ii) 1. 14OF THIS SUBPARAGRAPH, A member may not serve more than two consecutive terms of 5 15years. 162. A MEMBER WHOSE TERM IS SCHEDULED TO EXPIRE 17ON JUNE 30, 2019, MAY SERVE UP TO THREE CONSECUTIVE TERMS OF 5 YEARS. 18 (2)Except for the student member, no more than [3] THREE members of 19the Board of Regents who are not alumni of Morgan State University may be residents of other states. 2021A member appointed to fill a vacancy in an unexpired term serves only (3)22for the remainder of that term and until a successor is appointed and qualifies. 23Each member of the Board of Regents: (e) 24(1)Serves without compensation; and Is entitled to reimbursement for expenses in accordance with the 25(2)Standard State Travel Regulations. 2627SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July 281, 2018.
