## State Racing Commission - Equine Medical Director - Employment and Costs

- FOR the purpose of authorizing the State Racing Commission to employ an equine medical director under certain circumstances; requiring the Commission to direct that certain track licensees, certain owners and trainers, and certain breeders pay the cost of employing the equine medical director based on a certain percentage; and generally relating to the State Racing Commission and the employment of an equine medical director.

- 14 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
- 15 That the Laws of Maryland read as follows:

- 18 (a) On the recommendation of the executive director, the Commission may 19 employ additional employees or agents, including auditors, experts, guards, inspectors, a 20 breathalyzer operator at each harness racing track, scientists, Commission secretaries, 21 specimen collectors, veterinarians, AN EQUINE MEDICAL DIRECTOR, and others whom 22 the Commission considers to be essential at or in connection with a race meeting in the best 23 interests of racing.
- 24 (b) [The] EXCEPT AS PROVIDED IN SUBSECTION (E) OF THIS SECTION, THE

- 1 licensee who holds the race meeting for which an additional employee is used shall pay:
- 2 (1) the employer contribution for the employee under the Employees' 3 Pension System;
- 4 (2) the employer contribution, as determined by the Department of Budget 5 and Management, for the retiree under § 2–508 of the State Personnel and Pensions Article; 6 and
- 7 (3) an amount required under § 23–306.1(b) of the State Personnel and 8 Pensions Article, if any.
- 9 (c) A licensee who holds a race meeting shall employ and pay the officials at the 10 race meeting, other than stewards and harness judges, including each clerk of the course, 11 clerk of the scales, handicapper, paddock judge, patrol judge, placing judge, racing 12 secretary, starter, assistant starter, and timer.
- 13 (d) Notwithstanding any other provision of this title, if a licensee is required to allocate 0.25% of handle to either the Maryland Race Track Employees Pension Fund or the Maryland Harness Track Employees Pension Fund, the licensee shall first pay from the allocation any amounts required to be paid by the licensee under subsection (b) of this section and the remainder shall be paid to the appropriate pension fund.
- 18 (E) THE COMMISSION SHALL DIRECT THAT THE COST OF EMPLOYING THE 19 EQUINE MEDICAL DIRECTOR AUTHORIZED UNDER SUBSECTION (A) OF THIS SECTION 20 SHALL BE PAID:
- 21 (1) 80% BY THOROUGHBRED TRACK LICENSEES, GROUPS THAT 22 REPRESENT THOROUGHBRED OWNERS AND TRAINERS LICENSED IN THE STATE, 23 AND GROUPS THAT REPRESENT THOROUGHBRED BREEDERS IN THE STATE; AND
- 24 (2) 20% BY STANDARDBRED TRACK LICENSEES, GROUPS THAT REPRESENT STANDARDBRED OWNERS AND TRAINERS LICENSED IN THE STATE, AND GROUPS THAT REPRESENT STANDARDBRED BREEDERS IN THE STATE.
- SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July 1, 2018.
