CHAPTER _____

1 AN ACT concerning

2 **State Personnel – Collective Bargaining – State Institutions of Higher**
3 **Education**

4 FOR the purpose of clarifying that a member of the ~~State Labor Relations Board or State~~
5 Higher Education Labor Relations Board may petition the circuit court to order
6 certain entities to comply with an order from the Board; establishing that the failure
7 to meet an established negotiation deadline is an unfair labor practice for certain
8 entities under certain circumstances; ~~requiring a system institution in the~~
9 ~~University System of Maryland to designate a representative of the University~~
10 ~~System of Maryland Board of Regents to participate as a party in collective~~
11 ~~bargaining; providing for an extension of the effective period of a memorandum of~~
12 ~~understanding under certain circumstances; providing for the expiration of a~~
13 ~~memorandum of understanding under certain circumstances; and generally relating~~
14 to collective bargaining and State institutions of higher education.

12 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
 13 That the Laws of Maryland read as follows:

14 **Article – State Personnel and Pensions**

15 3–101.

16 (a) In this title the following words have the meanings indicated.

17 (b) “Board” means:

18 (1) with regard to any matter relating to employees of any of the units of
 19 State government described in § 3–102(a)(1)(i) through (iv) and (vi) through (x) of this
 20 subtitle and employees described in § 3–102(a)(2) of this subtitle, the State Labor Relations
 21 Board; and

22 (2) with regard to any matter relating to employees of any State institution
 23 of higher education described in § 3–102(a)(1)(v) of this subtitle, the State Higher Education
 24 Labor Relations Board.

25 (c) “Collective bargaining” means:

26 (1) good faith negotiations by authorized representatives of employees and
 27 their employer with the intention of:

28 (i) 1. reaching an agreement about wages, hours, and other
 29 terms and conditions of employment; and

30 2. incorporating the terms of the agreement in a written
 31 memorandum of understanding or other written understanding; or

32 (ii) clarifying terms and conditions of employment;

33 (2) administration of terms and conditions of employment; or

1 (3) the voluntary adjustment of a dispute or disagreement between
2 authorized representatives of employees and their employer that arises under a
3 memorandum of understanding or other written understanding.

4 (d) "Employee organization" means a labor or other organization in which State
5 employees participate and that has as one of its primary purposes representing employees.

6 (e) "Exclusive representative" means an employee organization that has been
7 certified by the Board as an exclusive representative under Subtitle 4 of this title.

8 (f) "President" means:

9 (1) with regard to a constituent institution, as defined in § 12-101 of the
10 Education Article, the president of the constituent institution;

11 (2) with regard to a center or institute, as those terms are defined in §
12 12-101 of the Education Article, the president of the center or institute;

13 (3) with regard to the University System of Maryland Office, the
14 Chancellor of the University System of Maryland; and

15 (4) with regard to Morgan State University, St. Mary's College of
16 Maryland, and Baltimore City Community College, the president of the institution.

17 (g) "System institution" means:

18 (1) a constituent institution, as defined in § 12-101 of the Education
19 Article;

20 (2) a center or institute, as those terms are defined in § 12-101 of the
21 Education Article; and

22 (3) the University System of Maryland Office.

24 (a) If ~~THE STATE~~, A PRESIDENT, A SYSTEM INSTITUTION, AN EXCLUSIVE
25 REPRESENTATIVE, OR a person fails to comply with an order issued by the Board, a
26 member of the Board may petition the circuit court to order the ~~STATE, PRESIDENT,~~
27 SYSTEM INSTITUTION, AN EXCLUSIVE REPRESENTATIVE, OR person to comply with the
28 Board's order.

29 (b) The Board shall not be required to post bond in an action under subsection (a)
30 of this section.

2 (a) The State and its officers, employees, agents, or representatives are prohibited
3 from engaging in any unfair labor practice, including:

4 (1) interfering with, restraining, or coercing employees in the exercise of
5 their rights under this title;

6 (2) dominating, interfering with, contributing financial or other support to,
7 or assisting in the formation, existence, or administration of any labor organization;

8 (3) granting administrative leave to employees to attend employer
9 sponsored or supported meetings or events relating to an election under § 3-405 of this
10 title, unless the employer grants employees at least the same amount of administrative
11 leave to attend labor organization sponsored or supported meetings or employee meetings;

12 (4) discriminating in hiring, tenure, or any term or condition of
13 employment to encourage or discourage membership in an employee organization;

14 (5) discharging or discriminating against an employee because of the
15 signing or filing of an affidavit, petition, or complaint, or giving information or testimony
16 in connection with matters under this subtitle;

17 (6) failing to provide all employee organizations involved in an election the
18 same rights of access as prescribed by the Board through regulation;

19 (7) engaging in surveillance of union activities;

20 (8) refusing to bargain in good faith; ~~{or}~~

21 (9) engaging in a lockout; ~~OR~~

22 ~~(10) UNLESS A WRITTEN AGREEMENT BETWEEN THE STATE, OR ITS~~
23 ~~OFFICERS, EMPLOYEES, AGENTS, OR REPRESENTATIVES, AND THE EXCLUSIVE~~

26 (b) Employee organizations and their agents or representatives are prohibited
27 from engaging in any unfair labor practice, including:

28 (1) interfering with, restraining, or coercing employees in the exercise of
29 their rights under this title;

30 (2) causing or attempting to cause an employer to discriminate in hiring,
31 tenure, or any term or condition of employment to encourage or discourage membership in
32 an employee organization;

1 (3) engaging in, inducing, or encouraging any person to engage in a strike,
2 as defined in § 3-303(a) of this subtitle;

3 (4) interfering with the statutory duties of the State or an employer;

4 (5) refusing to bargain in good faith; or

5 (6) not fairly representing employees in collective bargaining or in any
6 other matter in which the employee organization has the duty of fair representation.

7 **(C) (1) THIS SUBSECTION APPLIES TO A SYSTEM INSTITUTION, AN**
8 **EMPLOYEE ORGANIZATION FOR EMPLOYEES OF A SYSTEM INSTITUTION, AND ITS**
9 **OFFICERS, EMPLOYEES, AGENTS, OR REPRESENTATIVES.**

10 **(2) IN ADDITION TO THE UNFAIR LABOR PRACTICES IN SUBSECTIONS**
11 **(A) AND (B) OF THIS SECTION, A SYSTEM INSTITUTION AND AN EMPLOYEE**
12 **ORGANIZATION ARE PROHIBITED FROM FAILING TO MEET AN ESTABLISHED**
13 **NEGOTIATION DEADLINE, UNLESS A WRITTEN AGREEMENT BETWEEN THE SYSTEM**
14 **INSTITUTION, OR ITS OFFICERS, EMPLOYEES, AGENTS, OR REPRESENTATIVES, AND**
15 **THE EXCLUSIVE REPRESENTATIVE PROVIDES OTHERWISE.**

5 ~~in a timely manner for inclusion by the principal unit in its budget request to the Governor.~~

6 ~~(2) (i) The parties shall conclude negotiations before January 1 for any~~
7 ~~item requiring an appropriation of funds for the fiscal year that begins on the following~~
8 ~~July 1.~~

9 ~~(ii) In the budget bill submitted to the General Assembly, the~~
10 ~~Governor shall include any amounts in the budgets of the principal units required to~~
11 ~~accommodate any additional cost resulting from the negotiations, including the actuarial~~
12 ~~impact of any legislative changes to any of the State pension or retirement systems that~~
13 ~~are required, as a result of the negotiations, for the fiscal year beginning the following July~~

15 ~~(3) (i) If the parties do not conclude negotiations for the next fiscal year~~
16 ~~before October 25, either party may request that a fact finder be employed to resolve the~~

18 ~~(ii) The fact finder shall be employed no later than November 1.~~

19 ~~(iii) A fact finder shall be a neutral party appointed by alternate~~
20 ~~striking from a list by the parties provided:~~

~~(d) (1) A memorandum of understanding that incorporates all matters of agreement reached by the parties shall be executed by the exclusive representative and:~~

~~(i) for a memorandum of understanding relating to the State, the Governor or the Governor's designee;~~

~~(ii) for a memorandum of understanding relating to a system institution, the president of the system institution or the president's designee; and~~

~~(iii) for a memorandum of understanding relating to Morgan State University, St. Mary's College of Maryland, or Baltimore City Community College, the governing board of the institution or the governing board's designee.~~

~~(2) To the extent these matters require legislative approval or the appropriation of funds, the matters shall be recommended to the General Assembly for approval or for the appropriation of funds.~~

~~(3) To the extent matters involving a State institution of higher education require legislative approval, the legislation shall be recommended to the Governor for submission to the General Assembly.~~

~~(e) Negotiations for a memorandum of understanding shall be considered closed sessions under § 3-305 of the General Provisions Article.~~

~~(f) (1) The terms of a memorandum of understanding executed by the Governor or the Governor's designee and an exclusive representative of a bargaining unit for skilled service or professional service employees in the State Personnel Management System are not applicable to employees of a State institution of higher education.~~

~~(2) The terms of a memorandum of understanding executed by a president of a system institution or the governing board of Morgan State University, St. Mary's College of Maryland, or Baltimore City Community College, or their respective designees, and the exclusive representative of a bargaining unit for employees of a State institution of higher education are not applicable to skilled service or professional service employees in the State Personnel Management System.~~

(a) (1) A memorandum of understanding shall contain all matters of agreement reached in the collective bargaining process.

(2) The memorandum shall be in writing and signed by the exclusive representative involved in the collective bargaining negotiations and:

1 (i) for a memorandum of understanding relating to the State, the
2 Governor or the Governor's designee;

3 (ii) for a memorandum of understanding relating to a system
4 institution, the president of the system institution or the president's designee; and

5 (iii) for a memorandum of understanding relating to Morgan State
6 University, St. Mary's College of Maryland, or Baltimore City Community College, the
7 governing board of the institution or the governing board's designee.

8 (b) No memorandum of understanding is valid if it extends for less than 1 year or
9 for more than 3 years.

10 (c) (1) Except as provided in paragraph ~~[(2)]~~ ~~(2)(1)~~ of this subsection, a
11 memorandum of understanding is not effective until it is ratified by the Governor and a
12 majority of the votes cast by the employees in the bargaining unit.

13 (2) In the case of a State institution of higher education, a memorandum of
14 understanding;

16 board and a majority of the votes cast by the employees in the bargaining unit;
