1 AN ACT concerning

2 **Baltimore City – Park Heights Redevelopment Area – Alcoholic Beverages –**
3 **Store Closing Time**

4 FOR the purpose of altering the time during which establishments for which certain
5 alcoholic beverages licenses are issued in the Park Heights Redevelopment Area in
6 Baltimore City may sell alcoholic beverages; and generally relating to the sale of
7 alcoholic beverages in Baltimore City.

18 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
19 That the Laws of Maryland read as follows:

20 **Article – Alcoholic Beverages**

4 (a) (1) Except as provided in § 12-2005 of this subtitle, a holder of a Class A
5 beer and light wine license may sell beer and light wine:

6 (i) on Monday through Saturday:

7 1. from 9 a.m. to [midnight] **10 P.M.** in the Park Heights
8 Redevelopment Area that is specified in the Park Heights Master Plan adopted by the City
9 in 2006; and

10 2. from 6 a.m. to midnight in all other locations in the City;
11 and

12 (ii) on the Sundays that fall between Thanksgiving Day and New
13 Year's Day, from 1 p.m. to 9 p.m., if, on or before September 30 of that year, the license
14 holder has paid a supplementary license fee of \$75 for each Sunday the privilege is to be
15 exercised.

17 (a) (1) Except as otherwise provided in this subtitle, a holder of a Class A beer,
18 wine, and liquor license may sell beer, wine, and liquor:

19 (i) on Monday through Saturday:

20 1. from 9 a.m. to [midnight] **10 P.M.** in the Park Heights
21 Redevelopment Area that is specified in the Park Heights Master Plan adopted by the City
22 in 2006; and

23 2. from 6 a.m. to midnight in all other locations in the City;
24 and

25 (ii) on the Sundays that fall between Thanksgiving Day and New
26 Year's Day, from 1 p.m. to 9 p.m., if, on or before September 30 of that year, the license
27 holder has paid a supplementary license fee of \$75 for each Sunday the privilege is to be
28 exercised.

29 (c) Except as provided in § 12-2005 of this subtitle, a holder of a Class B-D-7
30 beer, wine, and liquor license may sell beer, wine, and liquor:

31 (1) from 9 a.m. to [2 a.m. the following day] **10 P.M.** in the Park Heights
32 Redevelopment Area that is specified in the Park Heights Master Plan adopted by the City

1 in 2006; and

2 (2) from 6 a.m. to 2 a.m. the following day in all other locations in the City.

3 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July
4 1, 2018.
