Estates and Trusts - Breach of Trust Action - Limitation Period

3 FOR the purpose of establishing that the terms of a trust do not prevail over certain periods 4 of limitation for bringing a judicial action; prohibiting a beneficiary from bringing a 5 judicial action against a trustee for breach of trust more than a certain period of time 6 after the date the beneficiary or the representative of the beneficiary is sent a certain report; providing that a certain report adequately discloses the existence of a 7 8 potential claim for breach of trust for certain purposes; providing that this Act does 9 not limit the time for bringing an action against a trustee for a breach of trust committed in bad faith or with reckless indifference to the purposes of the trust or 10 11 the interests of the beneficiaries; providing for the application of this Act; and 12 generally relating to time limits for bringing certain actions.

- 7 (A) A BENEFICIARY MAY NOT BRING A JUDICIAL ACTION AGAINST A
 8 TRUSTEE FOR BREACH OF TRUST MORE THAN 1 YEAR AFTER THE DATE THAT THE
 9 BENEFICIARY OR THE REPRESENTATIVE OF THE BENEFICIARY IS SENT A REPORT
 10 THAT ADEQUATELY DISCLOSES THE EXISTENCE OF A POTENTIAL CLAIM FOR
 11 BREACH OF TRUST AND INFORMS THE BENEFICIARY OR THE REPRESENTATIVE OF
 12 THE BENEFICIARY OF THE TIME ALLOWED FOR BRINGING A JUDICIAL ACTION.
- 13 **(B)** A REPORT ADEQUATELY DISCLOSES THE EXISTENCE OF A POTENTIAL CLAIM FOR BREACH OF TRUST IF THE REPORT PROVIDES SUFFICIENT INFORMATION SO THAT THE BENEFICIARY OR REPRESENTATIVE KNOWS OF THE POTENTIAL CLAIM OR SHOULD HAVE INQUIRED INTO THE EXISTENCE OF THE CLAIM.
- 17 (C) THIS SECTION DOES NOT LIMIT THE TIME FOR BRINGING AN ACTION
 18 AGAINST A TRUSTEE FOR BREACH OF TRUST COMMITTED IN BAD FAITH OR WITH
 19 RECKLESS INDIFFERENCE TO THE PURPOSES OF THE TRUST OR THE INTERESTS OF
 20 THE BENEFICIARIES.
- SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall be construed to apply only prospectively and may not be applied or interpreted to have any effect on or application to any action arising before the effective date of this Act.
- SECTION 3. AND BE IT FURTHER ENACTED, That this Act shall take effect October 1, 2018.
