A BILL ENTITLED

1 AN ACT concerning

2 **Motor Vehicles – Operation When Approaching Vehicle With Visual Signals**

3 FOR the purpose of requiring drivers approaching from the rear certain vehicles that are
4 stopped, standing, or parked on a highway and using certain visual signals to make
5 a lane change to an available lane not immediately adjacent to the stopped, standing,
6 or parked vehicle under certain circumstances, or to slow to a reasonable and
7 prudent speed that is safe for certain existing conditions under certain
8 circumstances; providing for the application of this Act; and generally relating to the
9 rules of the road when approaching certain vehicles.

20 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
21 That the Laws of Maryland read as follows:

1 (e) (1) THIS SUBSECTION APPLIES TO A STOPPED, STANDING, OR
2 PARKED VEHICLE THAT IS:

3 (I) 1. ON A HIGHWAY; AND

4 2. USING A VISUAL SIGNAL THAT MEETS THE
5 REQUIREMENTS OF § 22-218 OR § 22-218.2 OF THIS ARTICLE; AND

6 (II) 1. A COMMERCIAL MOTOR VEHICLE PROVIDING
7 EMERGENCY MAINTENANCE TO A DISABLED VEHICLE;

8 2. AN EMERGENCY VEHICLE;

9 3. A SERVICE VEHICLE AS DEFINED UNDER § 22-201 OF
10 THIS ARTICLE;

11 4. A TOW TRUCK THAT IS PROPERLY REGISTERED IN
12 ACCORDANCE WITH § 13-920 OF THIS ARTICLE; OR

13 5. A WASTE OR RECYCLING COLLECTION VEHICLE.

14 (2) Unless otherwise directed by a police officer or a traffic control device,
15 [when an emergency vehicle or a tow truck that is properly registered in accordance with §
16 13-920 of this article using any visual signal that meets the requirements of § 22-218 of
17 this article is stopped, standing, or parked on a highway, the driver of a motor vehicle
18 approaching the emergency vehicle or tow truck from the rear] **THE DRIVER OF A MOTOR
19 VEHICLE THAT APPROACHES FROM THE REAR A STOPPED, STANDING, OR PARKED
20 VEHICLE TO WHICH THIS SUBSECTION APPLIES** shall:

21 [(1)] (I) If practicable and not otherwise prohibited **AND WITH DUE
22 REGARD FOR SAFETY AND TRAFFIC CONDITIONS**, make a lane change into an available
23 lane not immediately adjacent to the [emergency vehicle or tow truck with due regard for
24 safety and traffic conditions] **STOPPED, STANDING, OR PARKED VEHICLE**; or

25 [(2)] (II) If the driver of the motor vehicle is unable to make a lane change
26 in accordance with item [(1) of this subsection] **(I) OF THIS PARAGRAPH**, slow to a
27 reasonable and prudent speed that is safe for existing weather, road, and vehicular or
28 pedestrian traffic conditions.

30 In this subtitle, “service vehicles” means any of the following vehicles that are
31 designated by the Administration as service vehicles:

1 (1) Vehicles of federal, State, or local agencies;

2 (2) Vehicles of public service companies; and

3 (3) Vehicles of persons performing governmental functions under a
4 contract with any federal, State, or local government.

6 (c) (6) Service vehicles, waste or recycling collection vehicles, rural letter
7 carrier vehicles, slow moving farm vehicles, and tow trucks may be equipped with or display
8 yellow or amber lights or signal devices.

9 (11) The yellow or amber lights or signal devices permitted on vehicles
10 under paragraph (6) of this subsection may be flashed or oscillated or otherwise used only
11 in the course of official duties, to indicate to the public that the vehicle is a slow moving
12 vehicle or otherwise is impeding traffic.

14 (a) One or more amber flashing lights may be displayed:

15 (1) By a tow truck while at the scene of an accident or a disabled vehicle or
16 while towing a vehicle; and

17 (2) By snow removal and other highway maintenance and service
18 equipment and escort vehicles.

19 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
20 October 1, 2018.
