4 FOR the purpose of establishing the Nonprofit Youth Development Program in the State Department of Education; establishing the purpose of the Program; requiring the 5 6 State Superintendent of Schools, in consultation with the People for Change 7 Coalition, Inc., to develop and administer the Program; requiring the Governor to 8 include a certain appropriation to the Program in each annual budget submission 9 beginning in a certain fiscal year; requiring a certain nonprofit organization to 10 submit a certain application to the State Superintendent to apply for grants from the 11 Program; requiring the State Superintendent to review certain applications and 12 award certain grants in a certain priority; requiring a certain percentage of grant 13 funds to be awarded to certain programs; limiting the amount a grantee may be 14 awarded each year; requiring the State Superintendent to adopt certain regulations; 15 defining certain terms; and generally relating to grants to nonprofit organizations to 16 support youth development programming.
