1 AN ACT concerning

2 **Consumer Protection – Credit Report Security Freezes – Notice and Fees**

3 FOR the purpose of prohibiting a consumer reporting agency from charging a fee for the
4 placement of a security freeze requested by a consumer or a certain consumer
5 representative ~~under certain circumstances~~; prohibiting a consumer reporting
6 agency from charging a fee for the temporary lift or removal of a security freeze that
7 has been placed on the consumer's credit report; altering the contents of a certain
8 notice that must be included with a certain summary of rights provided to a
9 consumer; and generally relating to credit report security freezes.

16 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,

17 That the Laws of Maryland read as follows:

2 may not be charged for any service relating to a security freeze.

3 ~~(2) A consumer reporting agency may charge a reasonable fee, not~~
4 ~~exceeding \$5, for each placement[, temporary lift, or removal] of a security freeze.~~

5 ~~(3) Notwithstanding paragraph (2) of this subsection, a consumer reporting~~

15 (j) At any time that a consumer is entitled to receive a summary of rights under
16 § 609 of the federal Fair Credit Reporting Act or § 14-1206 of this subtitle, the following
17 notice shall be included:

18 "NOTICE

19 You have a right, under § 14-1212.1 of the Commercial Law Article of the Annotated
20 Code of Maryland, to place a security freeze on your credit report. The security freeze will
21 prohibit a consumer reporting agency from releasing your credit report or any information
22 derived from your credit report without your express authorization. The purpose of a
23 security freeze is to prevent credit, loans, and services from being approved in your name
24 without your consent. **A CONSUMER REPORTING AGENCY MAY NOT CHARGE YOU A FEE**
25 **FOR ANY SERVICE RELATING TO A SECURITY FREEZE, INCLUDING FOR ANY**
26 **PLACEMENT, TEMPORARY LIFT, OR REMOVAL OF A SECURITY FREEZE.**

27 You may elect to have a consumer reporting agency place a security freeze on your
28 credit report by written request sent by certified mail or by electronic mail or the Internet
29 if the consumer reporting agency provides a secure electronic connection. The consumer
30 reporting agency must place a security freeze on your credit report within 3 business days
31 after your request is received. Within 5 business days after a security freeze is placed on
32 your credit report, you will be provided with a unique personal identification number or
33 password to use if you want to remove the security freeze or temporarily lift the security
34 freeze to release your credit report to a specific person or for a specific period of time. You
35 also will receive information on the procedures for removing or temporarily lifting a
36 security freeze.

1 If you want to temporarily lift the security freeze on your credit report, you must
2 contact the consumer reporting agency and provide all of the following:

3 (1) The unique personal identification number or password provided by the
4 consumer reporting agency;

5 (2) The proper identifying information to verify your identity; and

6 (3) The proper information regarding the person who is to receive the credit
7 report or the period of time for which the credit report is to be available to users of the
8 credit report.

9 A consumer reporting agency must comply with a request to temporarily lift a
10 security freeze on a credit report within 3 business days after the request is received, or
11 within 15 minutes for certain requests. A consumer reporting agency must comply with a
12 request to remove a security freeze on a credit report within 3 business days after the
13 request is received.

14 If you are actively seeking credit, you should be aware that the procedures involved
15 in lifting a security freeze may slow your own applications for credit. You should plan ahead
16 and lift a security freeze, either completely if you are seeking credit from a number of
17 sources, or just for a specific creditor if you are applying only to that creditor, a few days
18 before actually applying for new credit.

19 ~~A consumer reporting agency may charge a reasonable fee not exceeding \$5 for each
20 placement[, temporary lift, or removal] of a security freeze. However, a consumer reporting
21 agency may not charge any fee to a consumer who, at the time of a request to place[,
22 temporarily lift, or remove] a security freeze, presents to the consumer reporting agency a
23 police report of alleged identity fraud against the consumer or an identity theft passport. A
24 consumer reporting agency also may not charge any fee to a consumer for the first
25 placement of a security freeze [with the consumer reporting agency] **ON THE CONSUMER'S
26 CREDIT REPORT IN A CALENDAR YEAR, OR FOR THE TEMPORARY LIFT OR REMOVAL
27 OF A SECURITY FREEZE.**~~

28 A security freeze does not apply if you have an existing account relationship and a
29 copy of your credit report is requested by your existing creditor or its agents or affiliates for
30 certain types of account review, collection, fraud control, or similar activities.”

32 (c) (1) A consumer reporting agency shall place a security freeze for a
33 protected consumer if:

34 (i) The consumer reporting agency receives a request from the
35 protected consumer's representative for the placement of the security freeze under this
36 section; and

(ii) The protected consumer's representative:

1. Submits the request to the consumer reporting agency at the address or other point of contact and in the manner specified by the consumer reporting agency;

2. Provides to the consumer reporting agency sufficient proof of identification of the protected consumer and the representative; AND

3. Provides to the consumer reporting agency sufficient proof of authority to act on behalf of the protected consumer[; and

4. Pays to the consumer reporting agency a fee as provided in subsection (i) of this section].

(g) If a protected consumer or a protected consumer's representative wishes to remove a security freeze for the protected consumer, the protected consumer or the protected consumer's representative shall:

(1) Submit a request for the removal of the security freeze to the consumer reporting agency at the address or other point of contact and in the manner specified by the consumer reporting agency; **AND**

(2) Provide to the consumer reporting agency:

(i) In the case of a request by the protected consumer:

1. Proof that the sufficient proof of authority for the protected consumer's representative to act on behalf of the protected consumer is no longer valid; and

2. Sufficient proof of identification of the protected consumer;
or

(ii) In the case of a request by the representative of a protected consumer:

1. Sufficient proof of identification of the protected consumer and the representative; and

2. Sufficient proof of authority to act on behalf of the protected consumer[; and

(3) Pay to the consumer reporting agency a fee as provided in subsection (i) of this section].

23 (i) A consumer reporting agency may ~~charge a reasonable fee, not exceeding \$5,~~
