2 Public Safety – Handgun Permit – Church or Religious Organization Property

3 FOR the purpose of authorizing a person who has the consent of a certain church or 4 religious organization to carry a handgun on the property of the church or religious organization during certain events and has the intent to wear, carry, or transport a $\mathbf{5}$ 6 handgun for certain purposes on the property of the church or religious organization 7 to, without a permit, carry a handgun on the property of the church or religious 8 organization during certain events and transport a handgun to and from certain 9 church or religious organization events; and generally relating to permits to carry, 10 wear, or transport a handgun.

- SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
 That the Laws of Maryland read as follows:
- 18 Article Public Safety
- 19 5–303.

(A) [A] EXCEPT AS PROVIDED IN SUBSECTION (B) OF THIS SECTION, A person
 shall have a permit issued under this subtitle before the person carries, wears, or transports
 a handgun.

1 (B) A PERSON WHO HAS THE WRITTEN CONSENT OF THE GOVERNING BOARD 2 OF A BONA FIDE CHURCH OR RELIGIOUS ORGANIZATION TO CARRY A HANDGUN ON 3 THE PROPERTY OF THE CHURCH OR RELIGIOUS ORGANIZATION DURING SERVICES 4 AND GATHERINGS AND HAS THE INTENT TO WEAR, CARRY, OR TRANSPORT A 5 HANDGUN FOR PURPOSES RELATED TO SELF-PROTECTION OR THE PROTECTION OF 6 OTHERS WHILE ON THE PROPERTY OF THE CHURCH OR RELIGIOUS ORGANIZATION 7 MAY, WITHOUT A PERMIT:

- 8 (1) CARRY A HANDGUN ON THE PROPERTY OF THE CHURCH OR 9 RELIGIOUS ORGANIZATION DURING SERVICES AND GATHERINGS; AND
- 10(2) TRANSPORT A HANDGUN TO AND FROM SERVICES AND11GATHERINGS OF THE CHURCH OR RELIGIOUS ORGANIZATION.
- 12 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect 13 October 1, 2018.
