Article II – General Powers

16 The Mayor and City Council of Baltimore shall have full power and authority to 17 exercise all of the powers heretofore or hereafter granted to it by the Constitution of 18 Maryland or by any Public General or Public Local Laws of the State of Maryland; and in 19 particular, without limitation upon the foregoing, shall have power by ordinance, or such 20 other method as may be provided for in its Charter, subject to the provisions of said
