8 household purposes;

9 (ii) Employment purposes; or

10 (iii) Other purposes authorized under § 14–1202 of this subtitle.

11 (2) The term does not include:

12 (i) Any report containing information solely as to transactions or
13 experiences between the consumer and the person making the report;

14 (ii) Any authorization or approval of a specific extension of credit
15 directly or indirectly by the issuer of a credit card or similar device; or

16 (iii) Any report in which a person who has been requested by a third
17 party to make a specific extension of credit directly or indirectly to a consumer conveys his
18 decision with respect to the request, if the third party advises the consumer of the name
19 and address of the person to whom the request was made and the person makes the
20 disclosures to the consumer required under § 14–1212 of this subtitle.

21 **[(e)] (F)** (1) “Consumer reporting agency” means any person which, for
22 monetary fees, dues, or on a cooperative nonprofit basis, regularly engages in whole or in
23 part in the practice of assembling or evaluating consumer credit information or other
24 information on consumers for the purpose of furnishing consumer reports to third parties,
25 and which uses any means or facility of commerce for the purpose of preparing or furnishing
26 consumer reports.

27 (2) “Consumer reporting agency” does not include:

28 (i) A person licensed as a private detective agency or certified as a
29 private detective under the Maryland Private Detectives Act; or

30 (ii) A person who assembles and exchanges consumer credit
31 information with an affiliated person or a person who is owned or controlled by the same
32 entity, provided that, in the event of an adverse credit decision against a consumer based
33 on that information, the entity making the decision shall comply with the notice
34 requirements of § 14–1212(b) of this subtitle.

16 (c) (1) A consumer may elect to place a security freeze on the consumer's
17 consumer report by:

18 (i) Written request sent by certified mail;

19 (ii) Subject to paragraph (6) of this subsection, telephone, by
20 providing certain personal information that the consumer reporting agency may require to
21 verify the identity of the consumer; **OR**

22 (iii) [Electronic mail using an electronic postmark if a secure
23 electronic mail connection is made available by the consumer reporting agency; or

24 (iv) If the consumer reporting agency makes a secure connection
25 available on its Web site, an] **AN** electronic request **TRANSMITTED** through [that] **A** secure
26 connection **MADE AVAILABLE BY THE CONSUMER REPORTING AGENCY ON THE**
27 **WEBSITE OF THE CONSUMER REPORTING AGENCY.**

28 (2) A consumer reporting agency shall require a consumer to provide
29 proper identifying information when requesting a security freeze.

31 reporting agency shall place a security freeze on a consumer's consumer report within 3
32 business days after receiving a request under paragraph (1) of this subsection.

1 (4) Within 5 business days after placing a security freeze on a consumer's
2 consumer report, the consumer reporting agency shall:

3 (i) Send a written confirmation of the security freeze to the
4 consumer;

5 (ii) Provide the consumer with a unique personal identification
6 number or password to be used by the consumer when authorizing the release of the
7 consumer's consumer report to a specific person or for a specific period of time; and

8 (iii) Provide the consumer with a written statement of the procedures
9 for requesting the consumer reporting agency to remove or temporarily lift a security freeze.

10 (5) (i) Subject to subparagraph (ii) of this paragraph, a consumer
11 reporting agency is not required to place a security freeze on a consumer report if the
12 consumer reporting agency:

13 1. Acts only as a reseller of credit information by assembling
14 and merging information contained in a database of another consumer reporting agency or
15 multiple consumer reporting agencies; and

16 2. Does not maintain a permanent database of credit
17 information from which new consumer reports are produced.

18 (ii) A consumer reporting agency that acts as a reseller of credit
19 information shall honor a security freeze placed on a consumer report by another consumer
20 reporting agency.

21 (6) (i) If a consumer requests placement of a security freeze by
22 telephone under paragraph (1)(ii) of this subsection, the consumer reporting agency may
23 require the consumer to confirm the request in writing on a form that the consumer
24 reporting agency provides to the consumer with the materials sent in accordance with
25 paragraph (4) of this subsection.

16 1. Placement of the security freeze was based on a material
17 misrepresentation of fact by the consumer; or

18 2. The consumer:

19 A. Made the request to place the security freeze by telephone
20 under subsection (c)(1)(ii) of this section; and

21 B. Failed to confirm the request in writing if required in
22 accordance with subsection (c)(6) of this section.

23 (ii) If a consumer reporting agency intends to remove a security
24 freeze under subparagraph (i) of this paragraph, the consumer reporting agency shall notify
25 the consumer in writing of its intent at least 5 business days before removing the security
26 freeze.

27 (h) (1) Subject to subsection (g)(2) of this section, a security freeze shall remain
28 in place until the consumer requests that the security freeze be removed.

29 (2) If a consumer wants to remove a security freeze from the consumer's
30 consumer report, the consumer shall:

 2 Commissioner relating to the regulation of mortgage lending, mortgage origination, money
 3 transmission, debt management services, [and] debt settlement services, **AND CONSUMER**
 4 **REPORTING AGENCIES.**

5 (2) Any expenditures from the Fund to cover costs and expenses of the
 6 Commissioner may be made only:

7 (i) With an appropriation from the Fund approved by the General
 8 Assembly in the annual State budget; or

9 (ii) By the budget amendment procedure provided for in § 7-209 of
 10 the State Finance and Procurement Article.

11 (3) If, in any fiscal year, the amount of the revenue collected by the
 12 Commissioner and deposited into the Fund exceeds the actual appropriation for the
 13 Commissioner to regulate mortgage lending under Subtitle 5 of this title; mortgage
 14 origination under this subtitle; money transmission under Title 12, Subtitle 4 of this article;
 15 debt management services under Title 12, Subtitle 9 of this article; [and] debt settlement
 16 services under Title 12, Subtitle 10 of this article; **AND CONSUMER REPORTING**
 17 **AGENCIES UNDER TITLE 14, SUBTITLE 12 OF THE COMMERCIAL LAW ARTICLE**, the
 18 excess amount shall be carried forward within the Fund.

19 SECTION ~~4~~ 3. AND BE IT FURTHER ENACTED, That the powers and authority
 20 conferred by Section ~~14-1227~~ 14-1226 of the Commercial Law Article, as enacted by
 21 Section ~~3~~ 2 of this Act, shall be regarded as supplemental and additional to the powers and
 22 authority conferred by other laws on the Commissioner of Financial Regulation and may
 23 not be regarded as in derogation of any powers now existing in the Office of the
 24 Commissioner of Financial Regulation.

25 SECTION ~~5~~ 4. AND BE IT FURTHER ENACTED, That this Act shall take effect
 26 October 1, 2018.
