A BILL ENTITLED

1 AN ACT concerning

2 **High School Credit for College Courses Act of 2018**

3 FOR the purpose of requiring a county board of education to award certain elective credit
4 to a high school student who successfully completes a certain college course;
5 requiring a certain institution of postsecondary education to make a certain
6 certification that a certain course meets a specific high school graduation
7 requirement; establishing certain procedures for the State Department of Education
8 to make a certain determination relating to a certain certification; requiring a county
9 board to award certain credit required for graduation to a high school student who
10 successfully completes a certain college course; requiring the Department to
11 maintain a certain publicly available list on a certain website; defining certain terms;
12 and generally relating to awarding high school credit for a completed college course.

18 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
19 That the Laws of Maryland read as follows:

20 **Article – Education**

21 **7–211.**

22 **(A) (1) IN THIS SECTION THE FOLLOWING WORDS HAVE THE MEANINGS**
23 **INDICATED.**

EXPLANATION: CAPITALS INDICATE MATTER ADDED TO EXISTING LAW.

[Brackets] indicate matter deleted from existing law.



1 **(2) “COLLEGE COURSE” MEANS:**

2 **(I) A COURSE TAKEN AT AN INSTITUTION OF POSTSECONDARY**
3 **EDUCATION; OR**

4 **(II) A COURSE RECOGNIZED FOR CREDIT BY AN INSTITUTION OF**
5 **POSTSECONDARY EDUCATION IN THE STATE THROUGH AN APPROVED DIRECT**
6 **CREDIT ARTICULATION AGREEMENT AS DEFINED IN COMAR 13A.04.02.02.**

7 **(3) “INSTITUTION OF POSTSECONDARY EDUCATION” HAS THE**
8 **MEANING STATED IN § 10–101 OF THIS ARTICLE.**

9 **(B) A COUNTY BOARD SHALL AWARD A HIGH SCHOOL STUDENT ELECTIVE**
10 **CREDIT FOR SUCCESSFUL COMPLETION OF ANY COLLEGE COURSE FOR WHICH THE**
11 **STUDENT RECEIVES COLLEGE CREDIT FROM AN INSTITUTION OF POSTSECONDARY**
12 **EDUCATION.**

13 **(C) (1) THIS SUBSECTION APPLIES TO COLLEGE COURSES FOR WHICH A**
14 **STUDENT SEEKS CREDIT TO MEET A HIGH SCHOOL GRADUATION REQUIREMENT.**

15 **(2) THE INSTITUTION OF POSTSECONDARY EDUCATION OFFERING**
16 **THE COLLEGE COURSE SHALL:**

17 **(I) CERTIFY TO THE DEPARTMENT THAT THE COLLEGE**
18 **COURSE, IN THE INSTITUTION’S PROFESSIONAL JUDGMENT, MEETS A SPECIFIC**
19 **HIGH SCHOOL GRADUATION REQUIREMENT; AND**

20 **(II) IDENTIFY THE SPECIFIC HIGH SCHOOL GRADUATION**
21 **REQUIREMENT THAT THE COLLEGE COURSE WILL MEET.**

22 **(3) WITHIN 90 DAYS OF RECEIPT OF A COLLEGE COURSE**
23 **CERTIFICATION BY AN INSTITUTION OF POSTSECONDARY EDUCATION IN**
24 **ACCORDANCE WITH PARAGRAPH (2) OF THIS SUBSECTION, THE DEPARTMENT MAY**
25 **DETERMINE THAT THE COLLEGE COURSE DOES NOT MEET A SPECIFIC HIGH SCHOOL**
26 **GRADUATION REQUIREMENT.**

27 **(4) UNLESS THE DEPARTMENT DETERMINES THAT THE COLLEGE**
28 **COURSE DOES NOT MEET A SPECIFIC HIGH SCHOOL GRADUATION REQUIREMENT**
29 **WITHIN 90 DAYS OF RECEIPT OF THE COURSE CERTIFICATION, THE COLLEGE**
30 **COURSE IS DEEMED TO SATISFY THE HIGH SCHOOL GRADUATION REQUIREMENT.**

31 **(5) IF THE DEPARTMENT DETERMINES THAT THE COLLEGE COURSE**
32 **DOES NOT MEET A SPECIFIC HIGH SCHOOL GRADUATION REQUIREMENT, THE**

1 DEPARTMENT SHALL IDENTIFY:

2 (I) SPECIFIC CHANGES IN THE COLLEGE COURSE THAT WOULD
3 BE NECESSARY TO MEET THE SPECIFIC GRADUATION REQUIREMENT; AND

4 (II) THE PROCESS THAT MUST BE FOLLOWED TO MAKE THE
5 CHANGES TO THE COLLEGE COURSE THAT ARE NECESSARY TO MEET THE SPECIFIC
6 GRADUATION REQUIREMENT.

7 (D) A COUNTY BOARD SHALL AWARD A HIGH SCHOOL STUDENT CREDIT
8 THAT IS REQUIRED FOR GRADUATION IF:

9 (1) THE STUDENT HAS SUCCESSFULLY COMPLETED A COLLEGE
10 COURSE AT AN INSTITUTION OF POSTSECONDARY EDUCATION; AND

11 (2) THE DEPARTMENT HAS NOT DETERMINED THAT THE COLLEGE
12 COURSE DOES NOT MEET A SPECIFIC HIGH SCHOOL GRADUATION REQUIREMENT.

13 (E) THE DEPARTMENT SHALL MAINTAIN A PUBLICLY AVAILABLE LIST ON
14 THE DEPARTMENT'S WEBSITE OF COLLEGE COURSES THAT SATISFY A SPECIFIC
15 HIGH SCHOOL GRADUATION REQUIREMENT.

16 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July
17 1, 2018.
