- 14 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND.
- 15 That the Laws of Maryland read as follows:

- 18 (A) IN THIS SECTION, "EXTRACURRICULAR ACTIVITY" INCLUDES
- 19 INTERSCHOLASTIC ATHLETICS, MUSIC, DRAMA PROGRAMS, STUDENT
- 20 ORGANIZATIONS, AND OTHER PROGRAMS SPONSORED BY A SCHOOL:
- 21 (1) IN WHICH A STUDENT MAY PARTICIPATE OUTSIDE REGULAR
- 22 SCHOOL HOURS; AND
- 23 (2) FOR WHICH A STUDENT DOES NOT EARN ACADEMIC CREDIT.
