15 16	SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND, That the Laws of Maryland read as follows:

23	(2) for the use of a partnership, a corporation, an unincorporated

- 2 (B) (1) A SINGLE INDIVIDUAL MAY HOLD CLASS B BEER, WINE, AND

  4 LOCAL LICENSING BOARDS ONLY FOR RESTAURANTS, HOTELS, OR MOTELS
- $4\,$  Local Licensing boards only for restaurants, hotels, or motels.
- 5 (2) THE NUMBER OF LICENSES THAT A SINGLE INDIVIDUAL MAY HOLD 6 IS LIMITED ONLY BY THE CAP IMPOSED BY EACH LOCAL LICENSING BOARD ON THE

- [(b)] (C) Except as otherwise provided in Division II of this article or Title 3, Title 4, or Title 5 of this division, an individual may not be issued in the State more than
- one Class A, Class C, or Class D license for the use of:

- 16 (2) a partnership, a corporation, an unincorporated association, or a 17 limited liability company.
