### A BILL ENTITLED

#### 1 AN ACT concerning

# 2 Public Schools – Health and Safety Guidelines and Procedures – Digital Devices

- 3 FOR the purpose of requiring the State Department of Education, in consultation with the 4 Maryland Department of Health, on or before a certain date, to develop health and  $\mathbf{5}$ safety guidelines and procedures for the use of digital devices in public school 6 classrooms; requiring the State Department of Education, on or before a certain date, 7 to provide the guidelines and procedures to each county board of education for 8 consideration and adoption; requiring a county board that decides not to adopt the 9 guidelines and procedures to provide the State Department of Education an explanation of the basis for the decision; requiring the State Department of 10 Education to convene and consult with a certain workgroup, including 11 12representatives of certain entities; requiring the State Department of Education to 13 submit an interim report to the Governor and the General Assembly on or before a certain date; and generally relating to health and safety guidelines and procedures 14 15for the use of digital devices in public schools.

2 (A) (1) ON OR BEFORE JUNE 1, 2019, THE DEPARTMENT, IN 3 CONSULTATION WITH THE MARYLAND DEPARTMENT OF HEALTH, SHALL DEVELOP 4 HEALTH AND SAFETY GUIDELINES AND PROCEDURES FOR THE USE OF DIGITAL 5 DEVICES IN PUBLIC SCHOOL CLASSROOMS.

6 (2) ON OR BEFORE JULY 1, 2019, THE DEPARTMENT SHALL PROVIDE 7 THE GUIDELINES AND PROCEDURES TO EACH COUNTY BOARD FOR CONSIDERATION 8 AND ADOPTION.

9 (B) IF A COUNTY BOARD DECIDES NOT TO ADOPT THE GUIDELINES AND 10 PROCEDURES DEVELOPED UNDER SUBSECTION (A) OF THIS SECTION, THE COUNTY 11 BOARD SHALL PROVIDE TO THE DEPARTMENT AN EXPLANATION OF THE BASIS FOR 12 THE DECISION.

13 SECTION 2. AND BE IT FURTHER ENACTED, That:

14 (a) In developing the health and safety guidelines and procedures for the use of 15 digital devices in public school classrooms required under § 7–441 of the Education Article, 16 as enacted by this Act, the State Department of Education shall convene and consult with 17 a workgroup of affected stakeholders, including representatives from:

18 (1)the Maryland State Education Association; 19 (2)the Public School Superintendents Association of Maryland; 20(3)the Maryland Parent Teacher Association; the Maryland Association of Boards of Education; 21(4)22the Maryland Chapter, American Academy of Pediatrics; (5)23(6)MedChi, the Maryland State Medical Society; 24(7)the Campaign for a Commercial–Free Childhood; 25(8)Parents Across America; 26(9)the Environmental Influences on Child Health Outcomes (ECHO) 27program of the National Institutes of Health; 28(10)the Maryland Association of County Health Officers; 29the Mental Health Association of Maryland; (11)

1 (12)the Maryland Association of School Health Nurses;  $\mathbf{2}$ (13)the occupational safety and health profession; 3 the medical profession; and (14)4 any other entity with relevant expertise or whose members will be (15) $\mathbf{5}$ impacted by the guidelines and procedures. 6 (b) On or before December 1, 2018, the Department shall submit an interim report to the Governor and, in accordance with § 2-1246 of the State Government Article, 78 the General Assembly on the development of the guidelines and procedures for the use of 9 digital devices in public school classrooms.

10 SECTION 3. AND BE IT FURTHER ENACTED, That this Act shall take effect June 11 1, 2018.
