- 17 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
- 18 That the Laws of Maryland read as follows:

- 21 (e) Unless exempted under § 7–211, § 7–211.1, § 7–244, or § 7–501 of this article,
- 22 the interest or privilege of a person in property that is owned by the federal government,
- 23 the State, a county, a municipal corporation, or an agency or instrumentality of the federal
- 24 government, the State, a county, or a municipal corporation is subject to property tax as



- though the lessee or the user of the property were the owner of the property, if the property is leased or otherwise made available to that person:

- 25 (III) A COMMUNITY DEVELOPMENT AUTHORITY DESIGNATED 26 UNDER § 2–7–125 OF THE CODE OF PUBLIC LOCAL LAWS OF FREDERICK COUNTY.
- (2) This subsection does not apply to any reversionary interest of the federal government, the State, a county, or a municipal corporation, or an agency or instrumentality of the federal government, the State, a county, or a municipal corporation in property described in paragraph (1) of this subsection.
