1 AN ACT concerning

2 **Anne Arundel County – Orphans’ Court Judges – ~~Salary~~ Compensation**

3 FOR the purpose of ~~altering the salaries~~ repealing provisions of law that establish the
4 annual compensation of the judges of the Orphans’ Court for Anne Arundel County;
5 requiring the annual compensation of the judges of the Orphans’ Court for Anne
6 Arundel County to be as set by the County Executive and County Council of Anne
7 Arundel County; providing for the application of this Act; and generally relating to
8 the compensation of judges of the Orphans’ Court for Anne Arundel County.

14 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
15 That the Laws of Maryland read as follows:

16 **Article – Estates and Trusts**

17 2–108.

18 (c) (1) Each of the judges of the Court for Anne Arundel County shall receive
19 an annual compensation ~~of~~ AS SET BY THE COUNTY EXECUTIVE AND THE COUNTY
20 COUNCIL.

11 ~~(3)~~ **(2)** Each judge shall also receive an expense allowance up to \$150 per
 12 month for personal expenses incidental to his duties, to be paid by the Comptroller of Anne
 13 Arundel County each month upon presentation of an itemized voucher in accordance with
 14 rules and regulations prescribed by the Comptroller.

15 SECTION 2. AND BE IT FURTHER ENACTED, That, pursuant to Article III, § 35
 16 of the Maryland Constitution, this Act may not be construed to extend or apply to the salary
 17 or compensation of a judge of the Orphans' Court for Anne Arundel County while serving
 18 in a term of office beginning before the effective date of this Act, but the provisions of this
 19 Act concerning the salary or compensation of a judge of the Orphans' Court for Anne
 20 Arundel County shall take effect at the beginning of the next following term of office. This
 21 limitation does not apply to an individual appointed or elected after the effective date of
 22 this Act to fill out an unexpired term.

23 SECTION 3. AND BE IT FURTHER ENACTED, That this Act shall take effect
 24 ~~October~~ July 1, 2018.
