BY repealing and reenacting, with amendments, Article – Estates and Trusts Section 2–108(c) Annotated Code of Maryland (2017 Replacement Volume) SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND, That the Laws of Maryland read as follows: **Article – Estates and Trusts** 2-108. Each of the judges of the Court for Anne Arundel County shall receive (1)an annual compensation of: AS SET BY THE COUNTY EXECUTIVE AND THE COUNTY COUNCIL.

AND BE IT FURTHER ENACTED, That, pursuant to Article III, § 35 of the Maryland Constitution, this Act may not be construed to extend or apply to the salary or compensation of a judge of the Orphans' Court for Anne Arundel County while serving in a term of office beginning before the effective date of this Act, but the provisions of this Act concerning the salary or compensation of a judge of the Orphans' Court for Anne Arundel County shall take effect at the beginning of the next following term of office. This limitation does not apply to an individual appointed or elected after the effective date of this Act to fill out an unexpired term.
