SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
 That the Laws of Maryland read as follows:

# SUBTITLE 21. AWARD OF ATTORNEY'S FEES AND EXPENSES – VIOLATION OF MARYLAND CONSTITUTIONAL RIGHT.

## 9 **3–2101.**

10 (A) IN THIS SECTION, "SELF-EXECUTING" MEANS A PROVISION SO 11 COMPLETE THAT IT MAY BE ENFORCED BY A COURT WITHOUT THE NEED FOR 12 FURTHER LEGISLATIVE AUTHORITY OR DIRECTION.

13 **(B)** NOTWITHSTANDING ANY OTHER PROVISION OF LAW, A COURT MAY AWARD TO A PREVAILING PLAINTIFF REASONABLE ATTORNEY'S FEES AND 14EXPENSES FOR ANY CLAIM FOR RELIEF AGAINST THE STATE, ANY POLITICAL 15SUBDIVISION OF THE STATE, OR AN EMPLOYEE OR AGENT OF THE STATE OR ANY 16 POLITICAL SUBDIVISION OF THE STATE IF THE CLAIM FOR RELIEF SEEKS TO 17REMEDY A VIOLATION OF A RIGHT THAT IS SECURED BY A SELF-EXECUTING 18 19 PROVISION OF THE MARYLAND CONSTITUTION OR THE MARYLAND DECLARATION OF RIGHTS. 20

(C) A COURT MAY AWARD REASONABLE ATTORNEY'S FEES AND EXPENSES
TO A PREVAILING DEFENDANT ONLY ON A FINDING THAT THE CLAIM FOR RELIEF
BROUGHT BY THE PLAINTIFF TO REMEDY A VIOLATION OF A RIGHT THAT IS SECURED
BY A SELF-EXECUTING PROVISION OF THE MARYLAND CONSTITUTION OR THE
MARYLAND DECLARATION OF RIGHTS WAS MAINTAINED IN BAD FAITH OR WITHOUT
SUBSTANTIAL JUSTIFICATION.

(D) THE LIMITS ON ATTORNEY'S FEES PROVIDED UNDER § 12–109 OF THE
 STATE GOVERNMENT ARTICLE DO NOT APPLY TO AN AWARD OF ATTORNEY'S FEES
 UNDER THIS SECTION.

1 (B) THE COMBINED TOTAL OF ALL DAMAGES AND ATTORNEY'S FEES AND 2 EXPENSES AWARDED TO A PREVAILING PLAINTIFF UNDER THIS SUBTITLE MAY NOT 3 EXCEED:

4 (1) IF AWARDED AGAINST A LOCAL GOVERNMENT AS DEFINED IN § 5 5-301 OF THIS ARTICLE, THE LIMITS ON LIABILITY ESTABLISHED UNDER § 5-303 OF 6 THIS ARTICLE; OR

### 7 (2) IF AWARDED AGAINST THE STATE, THE LIMIT ON LIABILITY 8 ESTABLISHED UNDER § 12–104 OF THE STATE GOVERNMENT ARTICLE.

10 (a) (1) Subject to paragraph (2) of this subsection, the liability of a local 11 government may not exceed \$400,000 per an individual claim, and \$800,000 per total 12 claims that arise from the same occurrence for damages resulting from tortious acts or 13 omissions, or liability arising under subsection (b) of this section and indemnification under 14 subsection (c) of this section.

15 (2) The limits on liability provided under paragraph (1) of this subsection16 [do]:

(a) (1) Subject to the exclusions and limitations in this subtitle and
notwithstanding any other provision of law, the immunity of the State and of its units is
waived as to a tort action, in a court of the State, to the extent provided under paragraph
(2) of this subsection.

26 (2) The liability of the State and its units may not exceed \$400,000 to a 27 single claimant for injuries arising from a single incident or occurrence.

## 28 (3) THE LIMIT ON LIABILITY PROVIDED UNDER PARAGRAPH (2) OF 29 THIS SUBSECTION INCLUDES ANY ATTORNEY'S FEES AND EXPENSES AWARDED 30 UNDER § 3–2101 OF THE COURTS ARTICLE.
