- 3 FOR the purpose of authorizing a landowner to use a portion of the land subject to an easement to hold a certain special occasion event events for commercial purposes 4 5 under certain circumstances; specifying that a certain approval granted by the 6 Maryland Agricultural Land Preservation Foundation to a landowner to use the land 7 subject to an easement to hold a certain special occasion event events for commercial 8 purposes automatically terminates on the sale or transfer of the land subject to the 9 easement; providing for the application of this Act; and generally relating to the use 10 of land under an easement held by the Maryland Agricultural Land Preservation 11 Foundation.

- [(e)] **(F)** An agricultural land preservation easement purchased under this subtitle shall be included as part of a partnership under the Readiness and Environmental Protection Integration Program established under 10 U.S.C. § 2684a if:
- 14 (1) The land that is subject to an easement is in the vicinity of, or ecologically related to, the Atlantic Test Range;
- 16 (2) The landowner whose land is subject to an easement agrees to any restrictions imposed on the easement under the Readiness and Environmental Protection Integration Program established under 10 U.S.C. § 2684a; and
- 19 (3) Funding is available to the Foundation to enter into an agreement 20 under the Readiness and Environmental Protection Integration Program established under 21 10 U.S.C. § 2684a.
- SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall be construed to apply retroactively and shall be applied to and interpreted to affect agricultural preservation easements purchased or acquired by the Maryland Agricultural Land Preservation Foundation before the effective date of this Act.
- SECTION 3. AND BE IT FURTHER ENACTED, That this Act shall take effect June 1, 2018.
