A BILL ENTITLED

Task Force on Tax Policy, Reform, and Fairness

2 3 (Maryland Taxpayer Protection Act)

4 FOR the purpose of establishing the Task Force on Tax Policy, Reform, and Fairness; 5 specifying the membership of the Task Force; providing for the appointment of a 6 Senate cochair and House cochair of the Task Force; providing for the staffing of the 7 Task Force; prohibiting a member of the Task Force from receiving certain 8 compensation, but authorizing the reimbursement of certain expenses; requiring the 9 Task Force to study, consider, and make recommendations regarding certain matters; requiring the Task Force to report its findings and recommendations to the 10 11 Governor and the General Assembly on or before a certain date; providing for the termination of this Act; and generally relating to the Task Force on Tax Policy, Reform, and Fairness.

SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND, 14

- There is a Task Force on Tax Policy, Reform, and Fairness. (a)
- 17 (b) The Task Force consists of the following members:
- 18 (1) two members of the Senate of Maryland, appointed by the President of

19 the Senate:

20 (2) two members of the House of Delegates, appointed by the Speaker of

21 the House;

- (3) the Comptroller of the Treasury, or the Comptroller's designee;
- 23 **(4)** the Secretary of Budget and Management, or the Secretary's designee;

1	(5) a representative of the Maryland Association of Counties;
2	(6) a representative of the Maryland Chamber of Commerce;
3	(7) a representative of the Maryland Municipal League;
4 5	(8) a representative of the State Department of Assessments and Taxation, designated by the Director of Assessments and Taxation;
6	(9) one economist, appointed by the Governor;
7 8	(10) one member of the faculty of the University of Maryland School of Public Policy, appointed by the Governor;
9 10	(11) one member of the faculty of the University of Maryland Robert H. Smith School of Business, appointed by the Governor; and
11 12	(12) two members of the public, each of whom shall be an attorney at law or an accountant knowledgeable about the State's tax structure, appointed by the Governor.
13 14	(c) (1) The President of the Senate shall designate one of the members appointed from the Senate as cochair of the Task Force.
15 16	(2) The Speaker of the House shall designate one of the members appointed from the House of Delegates as cochair of the Task Force.
17 18	(d) The Office of the Comptroller and the Department of Budget and Management shall provide staff for the Task Force.
19	(e) A member of the Task Force:
20	(1) may not receive compensation as a member of the Task Force; but
21 22	(2) is entitled to reimbursement for expenses under the Standard State Travel Regulations, as provided in the State budget.
23	(f) The Task Force shall:
24 25 26	(1) study the current revenue structure of the State, including income, sales, corporate, motor fuel, excise, and property taxes, tax exemptions and credits, and fees;
27 28 29	(2) review the academic and economic research on state and local tax policy to assist in the overall assessment of efficacy, fairness, and competitiveness of the current revenue structure of the State;

review the revenue structure of neighboring jurisdictions for the

purpose of evaluating the regional competitiveness of the State's tax structure; 1 2 consider the nature of the State's economy and the importance of service 3 and professional businesses to economic development; 4 consider whether or not the current revenue structure of the State (5)should be reformed, modified, and modernized, including by considering: 5 6 reforms that would mitigate any adverse effects on State (i) 7 taxpayers that are the result of the federal Tax Cut and Jobs Act; 8 (ii) the imposition of a payroll tax, carried interest tax, or remote 9 sales tax in order to offset reductions to the State's income tax and State and local property 10 taxes; and 11 (iii) the encouragement of charitable contributions by taxpayers to 12 State institutions; and 13 (6) make recommendations regarding changes to the State's revenue 14 structure that: (i) promote job growth and economic development; 15 16 (ii) ensure fairness, simplicity, and transparency; 17 provide a stable, balanced, and reliable revenue stream, while (iii) 18 not reducing services; and 19 (iv) create a business-friendly environment. 20 (g) On or before December 1, 2019, the Task Force shall report its findings and 21recommendations to the Governor and, in accordance with § 2-1246 of the State 22Government Article, the General Assembly. SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July 23 1, 2018. It shall remain effective for a period of 2 years and, at the end of June 30, 2020, 24

this Act, with no further action required by the General Assembly, shall be abrogated and
