3 FOR the purpose of altering the salaries of the County Commissioners of Calvert County,
4 the Sheriff of Calvert County, and the County Treasurer of Calvert County;
5 providing for the application of this Act; and generally relating to the salaries of
6 public officials of Calvert County.

1 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
2 That the Laws of Maryland read as follows:

3 **Article 5 – Calvert County**

4 2–101.

5 (a) Five County Commissioners comprise the Board of County Commissioners of
6 Calvert County.

7 (b) (1) The annual salary of the president of the Board is:

8 (I) [\$41,500] **\$44,500** for calendar year [2006] **2018**;

9 (II) [\$42,500] **\$46,000** for calendar year [2007] **2019**;

10 (III) [\$43,500] **\$47,500** for calendar year [2008] **2020**; [and]

11 (IV) [\$44,500] **\$49,000** for calendar year [2009] **2021**; and

12 (V) **\$50,500 FOR CALENDAR YEAR 2022 AND** each subsequent
13 calendar year.

14 (2) The annual salary of each of the associate members of the Board is:

15 (I) [\$39,000] **\$42,000** for calendar year [2006] **2018**;

16 (II) [\$40,000] **\$43,500** for calendar year [2007] **2019**;

17 (III) [\$41,000] **\$45,000** for calendar year [2008] **2020**; and

18 (IV) [\$42,000] **\$46,500** for calendar year [2009] **2021**; and

19 (V) **\$48,000 FOR CALENDAR YEAR 2022 AND** each subsequent
20 calendar year.

21 (c) Each Commissioner may be reimbursed up to an annual total of \$2,000, for
22 any reasonable costs incurred by the Commissioner in carrying out the functions of the
23 office.

24 (d) A Commissioner may participate in the Calvert County Employees
25 Retirement Savings Plan.

14 (a) The annual salary of the County Treasurer of Calvert County is **[\$52,020]**
 15 **\$57,500.**

16 SECTION 2. AND BE IT FURTHER ENACTED, That, pursuant to Article III, § 35
 17 of the Maryland Constitution, this Act may not be construed to extend or apply to the salary
 18 or compensation of the County Commissioners of Calvert County, the Sheriff of Calvert
 19 County, or the County Treasurer of Calvert County while serving in a term of office
 20 beginning before the effective date of this Act, but the provisions of this Act concerning the
 21 salary or compensation of the County Commissioners of Calvert County, the Sheriff of
 22 Calvert County, or the County Treasurer of Calvert County shall take effect at the
 23 beginning of the next following term of office. This limitation does not apply to an individual
 24 appointed or elected after the effective date of this Act to fill out an unexpired term.

25 SECTION 3. AND BE IT FURTHER ENACTED, That this Act shall take effect
 26 October 1, 2018.
